Furthermore, please note that this review is for architectural standards only. The owner shall comply with all local, state and national requirements for this type of construction.

Resolved, that the Village of Spencerport ARB issue a Certificate of Appropriateness to Gary Inzana/Village Square Management for exterior renovations on building to be located at 123 – 127 S. Union Street, Spencerport NY.

Said renovations shall meet the following requirements.

- 1. Vinyl siding color to match existing color.
- 2. Entablature shall be consistent of the existing and material shall be at the discretion of the builder.
- 3. Existing storefront to be repaired and repainted to match existing colors, grey building, white trim and blue, gold and maroon accent colors.
- 4. Proposed entrance doors shall be consistent with existing door.
- 5. Structure should be kept in good condition as determined by the Village of Spencerport ARB.
- 6. After installation the applicant shall submit a photograph of the completed installation to the Village Clerk for the file.

Furthermore, all renovations shall be completed in accordance with all applicable local, state and federal codes and laws.
