Taste of Texas Richard Mogab 122 S Union Street Handi-cap ramp and Deck

Richard Mogab stated that Fire Marshall Kevin Kelly did a site inspection of the second story of the building for the purpose of determining the fire code requirements for egress from the second story. Kevin Kelly has determined that the original plans as submitted meet all requirements of the code.

Chairman Wohlers stated that the Board has received an answer to his question regarding the preference of a 3 or 4 sided dumpster enclosure from DPW Superintendent Tom West and he had no preference that his crew could work around either. It is the recommendation from this board that the dumpster be enclosed on all 4 sides. We are trying to improve that area.

Chairman Wohlers: Will there be any additional outside lighting?

Mr. Mogab: I am not sure yet we have flood lights already and we close at 8:00 pm weekdays and 9:00 pm on the weekends in the summer it is still light out.

- The deck and ramp shall be kept in good condition as determined by the VOS ARB.
