4. Signage will not be lit.
5. Sign to be installed in a safe manner.
6. The signage shall be kept in good condition as determined by the VOS ARB.
7. After installation the applicant shall submit a photograph of the completed installation to the Village Clerk for filing.

Donna Heiler: I proposed the same size as the Chilango's sign but now that we have a larger space I am not sure if we can go any larger than 15 sq ft.

The maximum size allowed is 20 sq feet.

Donna Heiler: I have hired someone to make those repairs along with fixing the windows and installing lighting that everyone else has so that it all matches. I didn't put a request in for lighting so I will have to come back for that.
