Attorney Eric Stowe stated that the new sign will be placed in the same spot and will be the same size. They now own the building and the tenants have changed. The new sign will have removable panels for any new changes in tenants in the future.

The ARB offered the following resolution:

Resolved, that the Architectural Review Board has granted final approval for a Certificate of Appropriateness for 52 Nichols Street LLC for signage to be located at 52 Nichols Street, Spencerport NY.

2. Signage shall be 2 sided and made of aluminum. Colors as shown blue background with white lettering.
3. Posts shall preferably be vinyl.
4. A crown to be installed on top of sign as a cover.
5. Signage will not be lit.
6. Signage to be installed in a safe manner.
7. Signage shall be kept in good condition as determined by the Village of Spencerport ARB.
8. After installation the applicant shall submit a photograph of the completed alteration to the Village Clerk for filing.

Curt Kenyon owner of the business stated that the new sign is the same footprint as the previous sign and the colors will be as shown on the diagram submitted. The sign will be lit by 3 goose neck lights After Board discussion is was decided that to remain consistent with other businesses on Union Street the hours that the sign is allowed to be lit will be during hours of operation and may remain on for one hour after the business closes. Chairman Wohlers also asked Mr. Kenyon to use LED lighting and that Owen McIntee Electric Superintendent can help assist him with that.

The ARB offered the following resolution:

Resolved, that the Architectural Board has granted final approval for Page Countryside for signage to be located at 415 S Union Street, Spencerport NY.

Such Certificate of Appropriateness was granted based on the following:

1. Replace existing signage with same size sign adding the new design.
2. Material to be omega board with vinyl lettering colors and logo as shown on application submitted to the ARB.
3. Signage to have 3 white gooseneck lights mounted above the sign.
4. Applicant to use LED lights.
5. Sign to be lit only during hours of operation and one hour after business closes.
6. Signage to be installed in a safe manner.
7. Signage shall be kept in good condition as determined by the VOS ARB.
8. After installation the applicant shall submit a photograph of the completed alteration to the Village Clerk for filing.

2. Colors and graphics on signage shall be as submitted to the ARB.
3. Applicant will use the existing lighting during hours of operation and one hour after business closes.
4. Signage to be installed in a safe manner.
5. Signage shall be kept in good condition as determined by the VOS ARB.
6. After installation the applicant shall submit a photograph of the completed alterations to the Village Clerk for filing.

Chairman Wohlers stated that this item has been on the agenda for three months and that the applicant did not appear for those meetings. The signage is already installed and does not meet the code requirements.

The board explained to the applicant that this sign is too small and needs to come down and be replaced with a sign that is consistent with other signs in the plaza.

Resolved, that the Architectural Review board hereby does not approve the sign which is installed presently at 26 Slayton Ave. The applicant may re-install a new sign with the following requirements.

1. Size of sign to be 28" x 84' with radius ends.

2. Sign material to be alumilite or sign board.
3. Color of sign to be dark green with white lettering and white border to match existing signs in the plaza.
4. Sign shall not be lit.
5. Signage to be installed in a safe manner.
6. Signage shall be kept in good condition as determined by the VOS ARB.
7. After installation the applicant shall submit a photograph of the completed alteration to the Village Clerk for filing.

Matt Brooks owner of the business stated that the sign material will be very dense with a structural steel arm to hang on the building. The sign will be hung on the upper left corner of the building where the elevation is high and the sign will not impede pedestrian safety nor will the sign block any other signs along the street.

There will not be any lighting as enough light already comes off of the lamp posts on Union Street.

The ARB offered the following resolution:

Resolved, that the Architectural Review Board has granted final approval to Matt Brooks for McColley's for signage to be located at 89 S Union Street, Spencerport NY.

Such Certificate of Appropriateness was approved based on the following.

1. Size and design of signage shall be as submitted to the ARB.
2. Sign material to be 2 inch foam board.
3. Sign colors to be black, forest green, and gold as shown on application submitted to the ARB.
4. Sign to be installed as shown on application to the ARB.
5. Sign shall not be lit.
6. Signage to be installed in a safe manner.
7. Signage shall be kept in good condition as determined by the VOS ARB.
8. After installation the applicant shall submit a photograph of the completed alterations to the Village Clerk for filing.
