James Peacock Maximum Tan 172 S Union Street Signage

Mr. Peacock stated that this was a similar situation the sign that is there is quite faded and old and does not match the current logo that they have at other locations. They are trying to bring all the locations up the same look. This will be the same size we are going to use the existing panels that are there and refurbish them with new paint and graphics. It will probably be about a two week period that we will have the signs down.

William Rutter: Are those corporate colors and design?

Mr. Peacock: Yes, they started incorporating that logo about a year ago at most of their other locations Spencerport is really about the last location they have to change.

William Rutter: Are there different options for the sign?

Mr. Peacock: No that is pretty much it.

Craig Byham: Have you ever considered a different background; will it be a white background?

Mr. Peacock: It is more of an off white like an eggshell white not a vibrant white. If we darkened up the background the graphics would have to change too, and the sun is part of showing that it is a tanning salon. It will blend in more than these photos show.

Chairman Wohlers stated that he had the same concerns with the background colors especially on the back of the building. Could it be more of a cream color rather than the pure white it would blend in better with other signs in the plaza?
