Ms. Gibbardo stated to the board that she had previously owned Abbots but had sold that business with a do not compete clause for 5 years. She has recently purchased 194 S Union Street and will be opening up an ice cream parlor in the spring of 2017.

This store will be walk up window service only. Presently this building is not handicapped accessible and they will be bringing the building up to code with a new handicapped accessible sidewalk and a 28' x 8' deck.

The decking material will be pressure treated wood with a redwood stain and vinyl railings.

Ms. Gibbardo is also requesting approval to replace the existing windows on the front of the building with double hung vinyl windows that will go up and down not sliders.

Above the windows she would like to install cloth awnings.

Liz Venezky asked if the tables shown on the drawings would be brought in and out each evening.

Ms. Gibbardo stated that the village code states that if your business is within 500 ft. of municipal parking your business would be compliant with village code her business is 498 ft. from municipal parking.

Ms. Gibbardo stated that those posts used to hold the old sign for the vets office and they will be removed along with the lights in the front.

- 4. Stain on new decking to be redwood proluxe stain.
- 5. All renovations to be kept in good condition as determined by the VOS ARB.
- 6. After renovations are completed the applicant shall submit a photograph of such to the Village Clerk for filing.
