Introduced by Chairman Byham seconded by Liz Venezky and carried unanimously to grant final approval to Linda Gibbardo of VIC'S of Spencerport located at 194 S Union Street, Spencerport NY for a new window and sign lighting at property located at same.

Such approval was granted with the following conditions:

- 1. Lighting shall consist of 1 gooseneck lamp either white or black to illuminate existing sign located on west side of building. Sign fixture shall be shielded and directed solely at the sign.
- 2. Lighting shall be LED.
- 3. Sign shall be illuminated between the hours of 7PM 10PM.
- 4. Replacement sliding style windows shall be the same size as existing windows (73 ½ x 49 ½).
- 5. Color shall remain white.
- 6. Windows and light shall be kept in good condition as determined by the VOS ARB.
- 7. After installation the applicant shall submit a photograph of the completed installation to the Village Clerk for filing.
