RESOLUTION ACCEPTING ADDENDUM No. 2 of the TRUNK SEWER FEASIBILITY STUDY

WHEREAS, the Village of Spencerport contracted with Monroe County and village engineer MRB/group to analyze alternatives for directing sanitary wastewater from its treatment plant on Big Ridge Road in the Village of Spencerport to facilities owned and maintained by Monroe County Pure Waters (MCPW) in the Towns of Greece or Gates; and

WHEREAS, on November 3, 2003, MRB/group completed such analysis and submitted for the Village's review and consideration "Addendum No. 2, Force Main Alternative for the Trunk Sewer Feasibility Study" (hereafter referred to as "Addendum No. 2"); and

WHEREAS, the Village Board, having reviewed and given due consideration to the evidence, calculations, and recommendations described in the Executive Summary and supporting sections of "**Addendum No. 2**",

NOW, HEREBY RESOLVES

SECTION 1: To accept "**Addendum No. 2**" as submitted by MRB/group, including all findings and recommendations.
