Whereas, the Village of Spencerport and the Town of Ogden have negotiated another Intermunicipal Agreement for Building Inspecting Code Enforcement and a-la-carte consulting services; and

Whereas, the "Intermunicipal Agreement" will now be for the calendar years 2005, 2006, and 2007 with the fee being \$23, 183.75 for 2005, \$24,343.00 for 2006, and \$25,561.00 for 2007; plus other charges for a-la-carte consulting service per the attached fee schedule; and

Whereas, the "Intermunicipal Agreement" becomes effective January 1, 2005 and upon appropriate Resolution of both Boards of the Village of Spencerport and Town of Ogden;

Section 1. The Village Board authorizes the Mayor to sign the "Intermunicipal Agreement" on behalf of the Village of Spencerport;

Section 2. That this resolution shall take effect immediately conditional upon an appropriate Resolution the Town of Ogden agreeing to building inspecting code enforcement and a-la-carte services so stated in this Resolution.
