Jack Crooks provided the Building Inspection/Fire Marshal/Code Enforcement monthly report.

Discussion ensued regarding the Davison subdivision and the process that the developer is taking.

Mayor Walker reminded Mr. Crooks that the Sign Law had been adopted.

Jack stated that he and Kevin Kelly will be taking the Sign Law to the business and reviewing the expectations of the law to avoid future problems.

Mayor Walker suggested that Kevin and Jack include board members in their process.

Trustee Marello volunteered to help with this process and will be conducting a survey with the businesses for future economic development.

Jack Crooks reviewed the Trolley Building break-in/vandalism issue and reviewed the additional security measures that have been taken.

Discussion ensued regarding Docking Law.

Discussion continued regarding the progress of the Trailer Law.

Kevin Kelly stated that he would continue to review the process and report at the next workshop meeting.

Trustee Marello questioned whether businesses can have outside speakers for music.

Mayor Walker asked Jack Crooks and Dick Olson to review the noise ordinance and a possible rewrite.

Richard Olson provided the monthly legal report.

Mr. Olson stated that the progress is being made on the Trolley Easement and the appraisal should be ready for the September 7, 2005 board meeting if the Labor Day holiday does not interfere.

Mr. Olson continued that a resolution regarding the consolidation of the fire department will be submitted for the September 7, 2005 board meeting.

Mr. Olson reviewed the easement agreement with the board. Discussion ensued regarding the Goldstein property and the water leak. Mr. Olson advised that the Village does not have the obligation to repair the water line.

Mr. Olson stated that a meeting needs to be set up between the Village and the fire department regarding the parking lot leases to arrive at an agreement.

Mr. Olson continued that the joint use agreement and Hilton electric agreement is still pending.

Mr. Olson reviewed a proposal from Sprint regarding the sale of the cell tower site. Discussion ensued regarding the proposal. The Mayor and the Trustees will review the proposal and determine a course of action.

Discussion ensued regarding security at the Trolley Depot and the Ogden Police Chief's suggestion that the Village assess the need for a full time police officer.

MRB Group reviewed the status of the overall Village Streets assessment and the Sewer I&I fee structure and program.

Discussion ensued regarding these projects.
