Mr. Linder continued that residents are converting their current heating systems to electric however there are requirements that the resident must comply with. Mr. Linder stated that the electric department will be offering to customers pictures of their homes using the thermo-imaging camera. These pictures will show customers the areas of their homes that are losing heat.

Superintendent Linder provided the board with cost information regarding the insulation of the ceiling of the new electric storage building. Mr. Linder continued that the IEEP will be able to pay for some of the costs associated with the insulation of the ceiling.

RESOLUTION AUTHORIZING EMINENT DOMAIN PROCEEDING

WHEREAS, pursuant to prior resolutions, the Village caused a trolley station to be moved to

Village property east of Union Street and north of East Avenue; and

WHEREAS, construction and renovations are underway to make the trolley station a visitors'

center for the Village and to provide services to boaters using the Erie Canal; and

WHEREAS, a necessary element of these services is municipal water being provided to the trolley

building; and

WHEREAS, the Village Attorney has attempted to negotiate an easement on property belonging

to Virginia Diehl and known as 126 S. Union Street, tax account No. 087.09-11-09; and

WHEREAS, in spite of oral representations that the easement was forthcoming, it has not been

received.

NOW, THEREFORE, BE IT RESOLVED:

SECTION 1. That the Board of Trustees authorizes the Mayor, with the assistance of the Village

Attorney, to take any and all steps necessary to obtain such an easement.

SECTION 2. That such steps shall be as set forth in the Eminent Domain Procedure Law and shall

include:

- a. Negotiation;
- b. Appraisal;
- c. Commencement of an action and filing of a Lis Pendens;
- d. Signing any and all documents necessary to accomplish the above.

SECTION 3. That any payment for the easement must be authorized by further resolution of this

Board.

SECTION 4. That this Resolution will take effect immediately.
