VILLAGE BOARD WORKSHOP MEETING March 15, 2006

Tom Pavone submitted the monthly engineering report. The following projects were highlighted.

Pump station/forced main project

Mayor Walker highlighted the major points of the early stages of the project. Discussion ensued regarding alternatives to the project. Trustee Russell questioned whether Monroe County has included this project as a line item in their budget. Mayor Walker responded that this question would be further researched. Tom Pavone commented that he understood that Monroe County has \$2 million in their budget for this project.

Tom Pavone stated that a survey of the inside profile and the canal bed is necessary to determine the placement of the pipes.

Discussion ensued regarding the cost of the projects necessary to start the Pump station/Forced main project.

I & I Study

Tom Pavone stated that report 2 is forthcoming along with repair/recommendations.

Discussion ensued regarding I&I Study.

Tom Pavone commented that this study will prove to outside agencies that the Village of Spencerport has been working towards eliminating I&I.

Zoning map update

Clerk Sullivan reviewed the comments and suggestions for zoning changes that she, Jack Crooks and Donna Stassen developed.

Attorney Olson commented that the zoning changes must conform to the Village of Spencerport comprehensive plan. If the zoning changes do not conform the changes cannot be made without changing the comprehensive plan.

Mayor Walker suggested that further research be done to determine the cost of rezoning the recommended properties.

Discussion ensued regarding the reasons for zoning changes.

Development Regulations

Tom Pavone commented that the regulations should be complete by 3/24/06.

Tom West commented that the Storm Water Regulations will be added to the Development Regulations when they are approved by the Village Board.

General discussion ensued regarding the projects below. Storm water mapping Davison property MCWA sidewalk repairs Electric department storage building WWTP roof replacement Drainage grant application Trolley Depot Paver update

Attorney

Dick Olson submitted the appraisal for the Diehl Property to purchase 22 feet from the south side of the property to Union Street to the back of the property towards the Trolley Depot. The amount of the appraisal is \$25,300.

Mayor Walker questioned the cost of the easements necessary from the Diehl's and Swarthout's to install the water service for the Trolley Depot.

Dick responded that the cost thus far is \$4,000 for the Diehl's and \$2,000 for Swarthout's. Eminent domain process would add another \$3,000 to the project.

Mayor Walker responded that for approximately \$7,000 the Village would have an easement but for \$25,300 the Village would own the property.

Superintendent West commented that he feels that purchasing the property would benefit the Village.

Mayor Walker confirmed that the Village owns that property directly behind the property in question.

Dick mentioned that the purchase of this property does allow the Village to own to the curb on the South side of the property, thus requiring an easement from Swarthout's if necessary to do work at that end of the property.

Discussion ensued regarding future scenarios regarding the property.

Dick Olson commented that he reviewed the finding of H&V Risk consultants regarding the Village of Spencerport's insurance policies. Dick stated that H&V did find some gaps in the Village's insurance policy and that measures need to be taken to improve these gaps and save money. Dick also commented on work that H&V has performed with other municipalities.

Discussion ensued regarding the types of coverage that the Village of Spencerport currently has.

BI/FM/CE

Kevin Kelly submitted his monthly report. Inspections were done at Abbott's Custard, Galley Restaurant, former Jim's Restaurant, Diehl's property and former Party Starts Here property.

Trustee Marello questioned the intentions of his letter to Abbott's Custard regarding the condition of the basement and the responsibilities of the landlord.

Kevin explained to Trustee Marello that the letter informed Abbott's that traditionally the responsibility of the basement falls onto the landlord however, as stated in his letter, further investigation is necessary.

Trustee Rauber confirmed that Collichio Music and Subway have a temporary sign permits.

H&V Risk Consultants

Brian Baty gave the following review of the Village of Spencerport's insurance policies.

Public officials are excluded on the umbrella policy and should be included. The workers compensation policy is basic and not the best policy or price. Safety company provides inadequate safety training and service. SMP does not provide enough coverage on equipment. However, the umbrella is well written although the building values appear to somewhat off.

Brain continued that if the Village of Spencerport wanted to pursue the bid process for insurance a list of assets would be provided to the agents solicited. If H&V was contracted to administer the bid process Brain would control the agents and companies that are solicited. Brian also recommended that the bid process take place approximately every 3 years.

General discussion ensued regarding insurance.
