APPROVAL OF MINUTES

PRIVILEGE OF FLOOR

Mrs. Swarthout thanked the board regarding the discussion last month regarding the movie production. She continued by thanking the board for their follow through sending a letter to the production company regarding issues of December 16, 2007. Mrs. Swarthout continued asking if a procedure was to be put in place regarding future communications to the business owners.

Mayor Walker responded that the board is in the process of developing a communication plan to administer to the business owners.

Mrs. Swarthout further commented on the length of time water main installation, the blocking of parking spaces and how that information was communicated to her and her husband.

Tom West responded that he communicated with Swarthouts on 3 or 4 occasions. Tom continued that unfortunately weather delays and MCWA delayed the project. Tom stated that he was under the impression that he had kept Mr. Swarthout informed of every part of the project.

Mrs. Quigley asked if any progress has been made to fill the plaza and if there is a Village ordinance prohibiting adult entertainment facilities.

Attorney Olson commented that there is such an ordinance and that adult entertainment facilities would only be allowed in an industrial area.

Mayor Walker commented that no progress has been made filling the plaza.

Sewers Committee – Trustee Rauber, Chairman

Trustee Rauber stated that the monthly flow for November was 1.25 million gallons. Trustee Rauber continued that this is another month over one million gallons. Trustee Rauber continued that 4.68" of precipitation fell during the month of January 2007.

Easement activity continues, the IMA with Monroe County should be approved at the February 13th legislature meeting. The design phase of the project is nearing completion and the pump station design is being developed. An informational meeting regarding the project is being scheduled with residents from the town of Gates and business owners in the Village Plaza.
