WHEREAS, should grant funding be secured, the **Town** and the **Village** would each pay 50% of the cost exceeding \$200,000.

WHEREAS, should grant funding be secured, the **Town** would store and perform all maintenance on the equipment, **with a maintenance agreement to share cost.**
