APPROVAL OF MINUTES

Motion was made by Mayor Walker, seconded by Trustee Hopson and carried that the minutes of the regular meeting held February 6, 2008 be approved as read.

Motion was made by Mayor Walker, seconded by Trustee Nellis-Ewell and carried that the minutes of the workshop meeting held February 14^{th} and 20^{th} be approved as read. Trustee Rauber abstained from the February 14, 2008 motion.

Public Hearing(s)

Mayor Walker opened the public hearing for Local Law 1/2008 at 7:00 p.m. to amend Chapter 130 of the Village of Spencerport entitled "Vehicles and Traffic" which would authorize village code enforcement officers to enforce certain regulations related to stopping, standing and parking of motor vehicles.

Trustee Rauber explained the proposed local law indicating that this local law will allow the Village to write a citation to individuals who park, stop or place a vehicle in violation of our local parking laws such as two hour parking, no overnight parking or a car being parked across the sidewalk for an extended amount of time.

Mayor Walker inquired as to the definition of parking, stopping and standing.

Attorney Keith O'Toole responded indicating that the terms are defined within the NYS traffic code.

Mayor Walker further inquired how this law will be applied to residents who have a short driveway and have no other choice but to park over the sidewalk.

Trustee Rauber responded that the intent of the local law will be applied to an individual who has been initially warned of the infraction and continues to park across the sidewalk.

Trustee Marello indicated that he is struggling with the enforcement of individuals who need to park across the sidewalk because of the length of their driveway.

Mayor Walker questioned the definition of a sidewalk and whether it should be added to the proposed law.

Attorney O'Toole indicated that he would research the definition of sidewalk and add it at a later date.

Mayor Walker closed the public hearing for Local Law 1/2008 at 7:15 p.m.

Mayor Walker opened the public hearing for Local Law 2/2008 at 7:15 p.m.

Trustee Rauber explained that Local Law 2/2008 is to amend Local Law 1/2007 governing the use and access to utility easements, to amend the application requirements for constructing a fence in an easement.

Trustee Rauber explained that the amendment would allow applicants to submit an instrument survey map showing the measurements and location of the proposed fence along with cut sheets from the fence manufacturer indicating the materials of the proposed fence.

Mayor Walker requested that the cut sheet from the fence manufacturer will indicate the removable part.

Trustee Rauber responded that the cut sheet will indicate the removable part of the fence.

Mayor Walker closed the public hearing for Local Law #2/2008 at 7:18 p.m.

Mayor Walker opened the public hearing for Local Law #3/2008 at 7:18 p.m.

Trustee Rauber explained that Local Law #3/2008 is to amend the zoning ordinance of the Village of Spencerport in order to regulate the sale of motor vehicles in the Village of Spencerport.

Trustee Rauber indicated that the proposed law will limit the number of cars and the amount of time residents can sell a vehicle on their property.

Mayor Walker questioned that the proposed law prohibits the placement of the vehicle in the roadway but does not limit where the vehicle is placed in the residents yard. Mayor Walker continued by asking if any consideration was given to only allowing the car to be placed in the driveway.

Trustee Rauber commented that the code review committee did not want to put those limitations on the resident.

Attorney O'Toole agreed that limiting the resident was not necessary.

Mayor Walker asked if there was a time limit as to how long a car can be for sale in a resident's property.

Discussion ensued regarding the length of a sale.

Trustee Marello commented that he does not like any cars for sale on resident's property.

Trustee Nellis-Ewell commented that the law has no provisions for that the placement of the vehicle should not impede the sight lines of people entering or exiting other properties.

Discussion ensued regarding the placement of vehicles and visibility of other motorists.

Mayor Walker closed the public hearing for Local Law 3/2008 at 7:26 p.m.

Mayor Walker opened the public hearing for Local Law 4/2008 at 7:26 p.m.

Trustee Rauber explained that Local 4/2008 is to provide for the administration and enforcement of the New York State Uniform Fire Prevention and Building Code.

Trustee Rauber indicated that this is the new NYS fire prevention and building code and that it is in the best interest of the Village to adopt this code.

Mayor Walker closed the public hearing at 7:34 p.m.

Attorney O'Toole commended that the fees are only for professional services and that should the expenses exceed the fees services would be discontinued.

Mayor Walker closed the public hearing at 7:37 p.m.
