Mayor Walker commented that the pump station is up and running. Mayor Walker continued that a vibration issue with one of the pumps still exists and the pump manufacturer has been contacted and is working with crews to correct the issue. As a result of this vibration issue Monroe County maybe requesting a modification of the pump. In addition drawings have been transferred to Monroe County and maintenance manuals are in the process of being transferred.

Mayor Walker added that the boring under the canal will not take place this winter but permits and plans are in place for an attempt in the fall of 2009 and winter 2010. At this time soil samples from the canal sediment are being analyzed to determine their contents and how contractors will handle the sediment materials. This process should help to avoid any surprises when the boring takes place. Monroe County Pure Waters will be completing their own bore under the canal in the area at the east end of Trolley Blvd to tie into the City conveyance system.

Mayor Walker explained that currently he, the Village Clerk and Attorney are moving forward with a revision to the sewer charge law to resemble the methods that Monroe County uses to compile the sewer charges. Operation and maintenance charges are based on water consumption and capital charges are based on debt service costs and units. Capital units are determined by the type of property as it relates to NYS Real Properties classifications and/or water consumption.

Clerk Sullivan commented on the following items:

- Work continues with computer initiatives replacement computers for the DPW and Electric departments have arrived and research has begun for an onsite server back up system.
- Consultant contracts have been renewed with the HR, EAP and Insurance consultants for the same rates as 2008. Further review of insurance rates will be reviewed at a future board meeting.
- Work continues to provide projections for the 2009/2010 sewer rates. Meetings with Spencerport Schools and Ogden have been scheduled to make school and town leaders aware of the changing process and preliminary charges.
- Working with MCPW to complete the final billing for waste water treatment from July-December 2008 after the VOS WWTP was decommissioned. Invoicing should be received by February 15th or 16th.
- Working with approximately four residents along with Jack Crooks and Donna Stassen regarding flood plane grievances with FEMA due to recent revisions to the flood plane maps.
- All summer concert dates have been filled with the exception of August 16th. Concerts start 6/7 -8/30.
 Requests for donations to support the concerts will go out next month and schedules to follow.

Superintendent of Public Works - Thomas M. West

Superintendent West commented on the following items:

- Work continues to remove trees that have become dangerous mostly on Coleman and Coolidge Ave.
 Replacement trees will be planted. Cardinal Landscaping will be helping to determine the best species of replacement trees.
- As of the end of January 2009 455 hours of overtime have been spent on snow removal. This is above average but still within budget. The sidewalk plow has had mechanical problems and is being repaired
- Changes have been implemented to use the smaller pickup trucks for salting opposed to using the large dump trucks. This change has resulted in a savings of fuel and wear and tear on the larger dump trucks. Superintendent West further explained that although our trucks do not have large amounts of miles on them the hours that they work have a greater effect on their performance.
- Possible tenant for the WWTP office building; if this tenant does not rent an ad will be placed on Craig's List. The street sign shop has been moved to an existing building at the former WWTP and trustees are encouraged to visit the shop.
- Will be participating DPW Advocacy day in Albany for the CHIPS program. The Association of Superintendents will be sponsoring Mr. West's attendance.
- Explained potential contract with Monroe County to participate in highway work. This would allow the Village to use Village equipment to generate income through County highway projects.
- Continue to work with Al Scheg on the buildings survey and will have a presentation at a future board meeting. At this time information is being gathered regarding the condition of the docks on the north side of the canal.
- OSHA training is scheduled with the Village of Churchville with PERMA. CPR training will be scheduled this year and Village will need to pay for CPR training this year due to the lack of trainers.
- Jim Reddick, Paul Robinson and Superintendent West will be attending a storm water regulations conference.
- Preliminary work has started for the installation of a sidewalk on Union Street from Brockport Spencerport Road to the proposed site of Tim Horton's almost to Page Appliances.
- Storage has been provided for Christmas on the Canal decorations at the WWTP buildings.

Trustee Hopson questioned if prices have been determined for the sidewalks.

Superintendent West responded that he is working on ascertaining costs.

Trustee Rauber commented that a very comprehensive report had been presented
