Mayor Walker called the meeting to order at 5:00 p.m.

Mr. Crooks commented on the following activities: an additional three unit townhouse is being built at the Canal Landing Subdivision; a spec house has been built on the corner of Evergreen Street and Glen Carin Court in the Eire view Landing Subdivision, one house has been built and is now occupied in the Collichio Subdivision and a duplex is being built on Pinecrest Drive by Michael LoPresti.

Mr. Crooks continued that three new businesses have opened in the Village Paradise Bay Gift Shop, Mangia/Mangia and the Lighthouse Restaurant.

Mr. Crooks further commented that work is starting up again regarding the drainage at 42 Nichols Street, the Adams Basin Bed and Breakfast will be participating with the Trolley Depot a NYS Parks Stamp program and that the condition of Spencerport Bowl continues to deteriorate.

Mayor Walker commented that Kevin Kelly has met with the manger of Subway Restaurant and they have agreed to not put up and more advertisement banners.

Discussion ensued regarding the FEMA Maps and Bauers Cove properties.

Attorney Olson explained that in order for an IMA to be developed for the Village and Town regarding a walking trail along the Monroe County Right of Way on the south side of the canal a legal description of the rail and easement for the trail are required. Attorney Olson indicated that he will continue to work with Dan Schum, Town of Ogden attorney to finalize this IMA.

Attorney Olson commented that the recommendation by the Village Planning Board to rezone the property on the south eastern corner of West Avenue and Martha Street from R-2 to R-3 should be done with the rezoning of all properties within the village that are not properly zoned and not rezone one property at a time.

A question was raised as to how long rezoning could take.

Attorney Olson responded a couple of months.

Attorney Olson and Superintendent McIntee indicated that draft #1 regarding the electric heat revision to the tariff is complete and being reviewed. Work on the Joint Pole agreement continues but is still incomplete.
