PUBLIC HEARING

Mayor Walker opened the public hearing at 7:03 p.m. for the 2009/2010 Budget

Mayor Walker explained that the Village Budget is broken into three funds: General in the amount of \$2.3 million, Sewer in the amount of \$1.2 million and Electric in the amount of \$3.2 million in operating funds.

Mayor Walker further explained that the General Fund is the only portion of the budget that is funded by taxes. Mayor Walker added that the amount to be raised by taxes is \$577,338 and that this is the same amount that was raised last year. The reminder of the budget will be taken from appropriated fund balance and reserve fund balance.

Mayor Walker continued by explaining the fees associated with Recycling and the Sewer Budget. In addition Mayor Walker explained the basis of the Electric Budget. Mayor Walker further explained details relating to the budget and various expenses associated with each budget.

Mayor Walker concluded that the complete budget is available in the Village Office for review during normal business hours.

Mayor Walker closed the public hearing at 8:00 p.m.

Mayor Walker explained that the project is nearly complete except for the boring under the canal.
