The remaining costs will be deducted from the participating employee's paycheck.

Any employee choosing to participate in the HDHC/HSA plan the maximum that the Village will contribute towards the HDHC/HSA will not exceed the cost of the Healthy Choices Plan. Any short fall in the employee's HSA and the annual maximum deductible will be the responsibility of the employee though pre-tax payroll deduction.

This contribution plan will be in effect for the next two (2) years.
