# VILLAGE BOARD WORKSHOP MEETING January 20, 2010

Mr. Crooks commented that a review meeting that took place regarding the plans that were submitted by Morgan Management for Village Plaza phase two and phase three for approval at the February 2010 Planning Board Meeting.

Mr. Crooks summarized that there are several items on the submitted plans for phase two and three continue to need to be addressed and that Morgan Management and their engineer, Costich Engineering, has the list of items that need addressing. Currently the outstanding items have not been addressed. Mr. Crooks continued that if these items are not addressed the Planning Board will table the application until the outstanding items are addressed.

Discussion ensued regarding the outstanding items and the various phases of the Village Plaza project and process of issuing permits.

Superintendent McIntee commented that he has spoken to the general contractor for Morgan Management indicating that electric heat is not allowed in new construction and that they must use natural gas heating units because it is available.

Mayor Lobene commented that if this project is going to work we need to make sure we are following the rules and codes.

Trustee Rauber commented that he agrees we should be following the Village Codes for this project.

Mr. Crooks commented that the Planning Board must decided how they would like to go forward with the approval process for phase two and three of the Village Plaza. He indicated that tabling the application is an option; conditional final approval is an option but it needs to be pretty black and white.

Mayor Lobene responded that she does not want to see it tabled however if Morgan does not get the things done on phase one in the next two weeks then the Planning Board can determine how to approve phase two and three.

Attorney Olson led a group discussion regarding possibility of reducing the number of large scale plans needed for the Planning Board.

Trustee Nellis-Ewell indicated that she will work to implement the plan in an effort to be greener.

Attorney Olson commented that a local law can be enacted to prohibit the conversion an existing apartment property to a condominium.

Mayor Lobene explained to the Village Board that the Town of Ogden is having a public hearing regarding condominiums.

Attorney Olson explained that the Town of Ogden has already enacted a code prohibiting the conversion of an existing apartment property to a condominium and that the proposed code up for public hearing will address prohibiting any new condominiums being built within the Town of Ogden.

Attorney Olson recommended that the Village should look into prohibiting the conversion of an existing apartment property into a condominium but feels that it is not necessary to prohibit the building of new condominiums due to the limited amount of undeveloped land within the Village limits.

The Village Board asked Attorney Olson to go forward to develop the local law to prohibit the conversion of apartments to condominiums.
