Superintendent of Public Works – Thomas M. West

Superintendent West commented on the following items:

- Observation is being done on drainage construction in the plaza.
- Bulk pick-up continues however it does seem that the amount is lighter than last year.
- Meeting is scheduled with Monroe County on 5/6 regarding Lyell Avenue.
- Confirmation from Attorney Olson was received indicating that the Village does own the stone wall located on the property of 132 Maplewood Avenue that is in need of repair.
- Superintendent West thanked Donna for her hard work and will be making presentations to the students and teachers at the school board meeting later in May. There were over 90 participants this year.
- Issues continue with the recycling truck and its emissions system.
- The Village of Churchville will be borrowing our 5" missal for boring under driveways
- Sidewalk committee is meeting May 6th at 7:00 p.m.
- June 5th and 6th Ogden Police Department will be doing training at the DPW site.
- The SFD will be using the Village gator and Polaris vehicles for their parade.
- An individual will be taking our leaf pile for compost.
- Electrical and mechanical issues are starting on the 11 year old refuse truck.

Superintendent of Electric – Owen McIntee

Superintendent McIntee commented on the following items:

- Cable for the plaza project has been ordered and a meeting is scheduled with the Tambe Electric.
- Additional Itron Meters have been received and the last section of meter replacements in the Lyell, Maplewood, Coleman and Coolidge area will be complete.
- The pole inventory process is starting this week.
- Flags and banners will be installed next week.
- A lighting layout needs to be completed and estimated for the Lyell Avenue project.
- Arrangements are being made for the MEUA Western Regional Meeting on June 24th.
- Attended MEUA meeting last week and work is being done to bring the municipalities under NYPA for administration instead of the PSC.
- Distributed the IEEP annual report to the Village Board.

Attorney – Richard J. Olson

Attorney Olson commented that the Village's recycling truck is having issues with the emissions system since the vehicle is only used at low speeds and short distances this is causing the exhaust and emissions system to plug up resulting is down time for the truck. The solution to this problem is to start using the manual burn system installed in the truck by reconfiguring the computer system. This will result in high temperatures coming from the vehicle.

Superintendent West indicated that the manufacturer will be coming out to the Village to train all of the staff on this system and what should be expected.

Mayor Lobene commented that Carl Ayers and Bill Donahue will be the Village's canal ambassadors for the 2010 canal season.

Mayor Lobene acknowledged all of the people that helped with Day of Caring and that for some of the student advisors it was their 7th year attending.
