Treasurer Kimbler presented to the Village Board the current financial status of the Village. She indicated in her presentation that the general, electric and sewer funds are all with budget forecasts and expenses in all funds will be either at the forecasts or below.

Treasurer Kimbler continued by suggesting to the Village Board that the electric fund should begin to pay back their short term general fund borrow starting this fiscal year (09/10) and continue as planned in the upcoming fiscal years until the borrowing is repaid. She further commented that electric fund revenues are down 6.7% however the cost of electricity is down 14.5% during the same period.

Discussion ensued regarding cost saving measures that the electric department implemented during this fiscal year and the process for the repayment of the general fund short term borrowing.

BOND RESOLUTION DATED MAY 19th, 2010.

A RESOLUTION AUTHORIZING THE RECONSTRUCTION OF ROADS IN AND FOR THE VILLAGE OF SPENCERPORT, MONROE COUNTY, NEW YORK, AT A MAXIMUM ESTIMATED COST OF \$145,000 AND AUTHORIZING THE ISSUANCE OF \$145,000 SERIAL BONDS OF SAID VILLAGE TO PAY THE COST THEREOF.

BE IT RESOLVED, by the affirmative vote of not less than two-thirds of the total voting strength of the Board of Trustees of the Village of Spencerport, Monroe County, New York, as follows:

<u>Section 1.</u> The reconstruction of roads in and for the Village of Spencerport, Monroe County, New York, including sidewalks, gutters, drainage, landscaping, grading or improving

rights-of-way and other improvements and costs incidental thereto, is hereby authorized at a maximum estimated cost of \$145,000.

<u>Section 2.</u> It is hereby determined that the aforesaid class of objects or purposes constitutes a Type II action as defined under the regulations of the State of New York, promulgated under the State Environmental Quality Review Act which, by definition, will not have a significant adverse impact upon the environment.

<u>Section 3.</u> It is hereby determined that the plan for the financing of the aforesaid maximum estimated cost shall be by the issuance of \$145,000 serial bonds of said Village hereby authorized to be issued therefor pursuant to the provisions of the Local Finance Law.

<u>Section 4.</u> It is hereby determined that the period of probable usefulness of the aforesaid class of objects or purposes is at least five years, pursuant to subdivision 20 of paragraph a of Section 11.00 of the Local Finance Law. It is hereby further determined that the maximum maturity of the serial bonds herein authorized will not exceed five years.

Section 5. The faith and credit of said Village of Spencerport, Monroe County, New York, are hereby irrevocably pledged for the payment of the principal of and interest on such bonds as the same respectively become due and payable. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such bonds becoming due and payable in such year. There shall annually be levied on all the taxable real property of said Village, a tax sufficient to pay the principal of and interest on such bonds as the same become due and payable.

Section 6. Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the serial bonds herein authorized, including renewals of such notes, is hereby delegated to the Village Treasurer, the chief fiscal officer. Such notes shall be of such terms, form and contents, and shall be sold in such manner, as may be prescribed by said Village Treasurer, consistent with the provisions of the Local Finance Law.

<u>Section 7.</u> All other matters except as provided herein relating to the serial bonds herein authorized including the date, denominations, maturities and interest payment dates, within the limitations prescribed herein and the manner of execution of the same, including the

consolidation with other issues, and also the ability to issue serial bonds with substantially level or declining annual debt service, shall be determined by the Village Treasurer, the chief fiscal officer of such Village. Such bonds shall contain substantially the recital of validity clause provided for in Section 52.00 of the Local Finance Law, and shall otherwise be in such form and contain such recitals, in addition to those required by Section 51.00 of the Local Finance Law, as the Village Treasurer shall determine consistent with the provisions of the Local Finance Law.

<u>Section 8.</u> The validity of such bonds and bond anticipation notes may be contested only if:

- Such obligations are authorized for an object or purpose for which said Village is not authorized to expend money, or
- 2) The provisions of law which should be complied with at the date of publication of this resolution are not substantially complied with,

and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or

3) Such obligations are authorized in violation of the provisions of the Constitution.

<u>Section 9.</u> This resolution shall constitute a statement of official intent for purposes of Treasury Regulations Section 1.150-2. Other than as specified in this resolution, no monies are, or are reasonably expected to be, reserved, allocated on a long-term basis, or otherwise set aside with respect to the permanent funding of the object or purpose described herein.

Section 10. This resolution, which takes effect immediately, shall be published in summary form in the official newspaper of said Village for such purpose, together with a notice of the Village Clerk in substantially the form provided in Section 81.00 of the Local Finance Law. The question of the adoption of the foregoing resolution was duly put to a vote on roll call, which resulted as follows:
