# **Budget Presentation**

Treasurer Kimbler led the Village Board in an exercise to establish the Mayor and Trustees initiatives for the up-coming fiscal year.

### BI/FM/CE

Jack Crooks, Building Inspector submitted a written report with Clerk Sullivan.

# **Public Hearing**

Mayor Lobene opened the public hearing for Local Law 14-2010 "A Local Law to Amend the Zoning Law of the Village Spencerport" and the continuation of the open public hearing for Local Law 13-2010 from October 20, 2010 "A Local Law to Revise the Moratorium on the Construction of, Use Variance or Site Plan for, or the Conversion to, Multifamily Dwellings in the Village of Spencerport" at 6:00 p.m.

Attorney Olson indicated that on Local Law 14-2010 minor grammatical changes have been made that do not require a new public hearing. The changes were as follows:

H. 1. The term "a" was deleted and changed to "no more than a". H. 2. The term "unit" was deleted and changed to "building". Section 140-15 A – The letter "b" was changed to "c".

Attorney Olson further explained that the Village received a letter from Land Tech addressed to the Mayor suggesting that the law be changed to "no more that a two family dwelling" which was done and that the square footage is too restrictive. Attorney Olson explained that the square footage is comfortable for the Village and the Building Inspector and limits the size of the building to not become overly massive and if a building exceeds the limits the applicant can go before the Zoning Board of Appeals for a variance. Additionally there was some confusion on studio units and that they are not allowed in this district just 1, 2 and 3 unit dwellings and that parking is too restrictive however no changes were made. Attorney Olson added that the Building Inspector, Jack Crooks insisted that 4 parking spaces are necessary per unit and that the developer can ask the Zoning Board of Appeals for a variance for parking.

Mayor Lobene indicated that she thought that the Village was not going to allow three bedrooms.

Attorney Olson responded that the minimum will be 2 bedrooms and that 3 bedrooms will be allowed.

Trustee Hopson requested clarification regarding studio apartments.

Attorney Olson explained that studio apartments are allowed in two family dwellings but not allowed in three or more family dwellings.

Mayor Lobene closed the public hearings for Local Law 13 and 14 at 6:10 p.m.

# **Attorney**

Attorney Olson commented that he continues to work on the transfer of the Pump Station to Monroe County and no action has taken place with litigation issues.

Attorney Olson explained the quote received from Metro Appraisal not to exceed \$1,400. Attorney Olson continued that this is not a typical appraisal and that it should look similar to the report that Treasurer Kimbler submitted however a second opinion is helpful.

Trustee Rauber questioned if there is a separate set of metrics to appraise this type of lease.

Attorney Olson commented that \$1,400 is a small percentage of the potential payment in an effort to be well informed.

Treasurer Kimbler distributed to the Village Board information regarding the Board's fiscal responsibilities and the Village's fiscal status at this time.

Mayor Lobene acknowledged that sales tax has been received and is up from last year at this time. Mayor Lobene continued that she, Trustee Gunther and Clerk Sullivan will be working with the school district to foster a better relationship. Mayor Lobene indicated that the Waterfront Development Committee continues to work to develop a plan for a future park at the DPW.

Mayor Lobene asked the Board if they would think about adding Martin Luther King and Veterans Day to Village holidays.

Trustee Rauber explained the history of Village holidays.

Trustee Nellis-Ewell questioned who she should talk to about the Village Plaza sign.

Mayor Lobene responded Morgan Management.
