Mayor Lobene indicated that Dr. Robert Sudlow presented a signed petition from the neighbors regarding an additional stop sign at Morningside Drive and Hawthorne Road because of increased traffic. Mayor Lobene added that a resident from Deerborne Lane contacted her regarding speeding traffic and questioned if a "children at play" sign could be installed.

Superintendent West indicated that our insurance company does not endorse the installation of those signs.

Trustee Rauber commented that there is nothing requiring Board action and the DPW crews are working on the dock project at this time.

Trolley Depot - Trustee Rauber, President

Trustee Rauber commented that the group is looking at potentially growing the foot print of the building and the possibly increasing the library facilities. The group is also reviewing the grant opportunities available.

Mayor Lobene questioned if a room could be developed to be large enough to have a public meeting and be handicapped accessible.

Trustee Rauber responded that space is limited and size of the room maybe restricted.

Mr. Granger suggested bringing back the bridge tenders building back to the Village.

Trustee Rauber responded that the bridge tenders building is being considered.

Mayor Lobene added that she, Clerk Sullivan and Superintendent West met with the Canal Corp. last week and the Canal Corp. indicated that grant monies maybe available for project on the canal.

Mr. Kris Schultz discussed the potential of 4000' of trail to connect the south side of the canal west to the Canal Landing professional buildings on Spencerport Road.

Trustee Penders further explained that by completing these external reviews on an annual basis will decrease the Village's potential for being audited by the State Comptroller's Office.

Mayor Lobene asked Clerk Sullivan for her opinion on an external review of the Village's financial books being completed.

Clerk Sullivan responded that she and Treasurer Kimbler have discussed the annual review of the Village's financial books and that it is an excellent process to confirm that all financial transactions are consistent.

Clerk Sullivan commented that the year-end Village Board Meeting will be Tuesday, May 31, 2011 4:00 p.m.; reimbursement paperwork has been submitted and accepted for the docks; the balance of the CDBG program will be able to be applied to the ADA ramps and path to the docks; and the department of state will be contacted to potentially reconfigure the grant to help pay for lighting and some of the proposed walking trail; Margaret Gioia is making significant progress and has really stepped up her game.

Superintendent of Public Works – Thomas M. West

Superintendent West thanked Clerk Sullivan for her help with the dock project. Superintendent West continued by describing the pathway reconstruction and the overall progress of the dock construction.

Mayor Lobene added that Crane Hogan has done an excellent job on the project.

Superintendent West continued that crews are completing bulk pick up this week. Modifications have been done to the refuse truck for the toters and all dumpsters have been repaired and that John Stassen has done an excellent job with these repairs. Repairs on the Gazebo will be starting next week.

Superintendent of Electric – Owen McIntee

Superintendent McIntee indicated that his monthly report and a summary of the MEUA Annual meeting were emailed to the Village Board.

Superintendent McIntee explained that Fairport's rear lot pole setter is available for purchase and that this piece of equipment is beneficial to SME because of the high percentage of back yard infrastructure and has been borrowed from Fairport on many occasions for setting poles.

Trustee Gunther questioned if \$5000 was the minimum bid.

Superintendent McIntee responded that he does not know what the minimum bid is but feels that the item can be purchased for about \$5000.

Mayor Lobene questioned why Fairport is getting rid of their old pole setter.

Superintendent McIntee indicated that old pole setter was not able to work with Fairport's voltage and a much larger type of pole setter is needed in Fairport.

Trustee Rauber commented that this piece of equipment is extremely useful to SME.

Mayor Lobene questioned if this piece of equipment is in good working order.

Superintendent McIntee confirmed that the equipment is in good working order.

Trustee Penders commented that SME has many aged poles and that a pole setter would be a safer method of installing and/or replacing utility poles.
