APPROVAL OF MINUTES

A motion was made by Trustee Gunther, seconded by Trustee Penders and carried that the minutes from the October 5, 2011 regular meeting be approved as read. Trustee Nellis-Ewell abstained.

A motion was made by Trustee Penders, seconded by Trustee Nellis-Ewell and carried that the minutes from the Workshop October 19, 2011 workshop meeting be approved as read. Trustee Nellis-Ewell abstained.

PRIVILEGE OF FLOOR

Mrs. Quigley, Maplewood Avenue indicated that the drivers for Villager Construction are doing an excellent job observing the speed limit on Maplewood Avenue and being respectful to the residents.

Administrative Committee – Mayor Lobene, Chair

Mayor Lobene commented that the Village has experienced several incidents involving youth and most recently there was graffiti painted on the new Dollar Store in the plaza. Mayor Lobene continued that it was suggested that a neighborhood watch group for the business district might be appropriate.

Ogden Police Chief Nordquist addressed the Village Board regarding the types and amount of crime within the Town of Ogden and Village of Spencerport. Chief Nordquist summarized that this area does not experience a high amount of serious crime but experiences more quality of life incidents including graffiti, youth issues, traffic violations, etc. Chief Nordquist added that he is in contact with the business owners weekly to address any issues or concerns and that his officers are directed to walk the business district at least once per shift.

Chief Nordquist continued that there are several neighborhood watch groups throughout the Town and Village and that the police department fully supports all of the neighborhood watch groups. Chief Nordquist indicated that the Manitou Road neighborhood watch group has an internet news letter and residents submit information on goings on the town and crime prevention services.

Mayor Lobene indicated that the north end of the plaza will need to be rezoned from industrial to commercial to allow for the plaza owners to design and build additional multi-use buildings for commercial and residential occupancy.

Attorney Olson commented that he will be working with the code review committee to make changes to allow for mixed use of commercial and residential. Attorney Olson indicated that NYS Court of Appeals requires municipalities to provide for areas to be for adult uses and that a portion of the plaza needs remain zoned industrial for this purpose.

Mayor Lobene commented that the area Towns and Villages are being approached by a snowmobile club for permission to snowmobile along the canal within the Village limits.

Trustee Gunther commented that he thinks the Village should allow snowmobiling and see how it goes.

Trustee Nellis-Ewell commented that the club should present their request to the Village Board.

Trustee Penders indicated that the Town of Sweden allows snowmobiling along the canal.

Mayor Lobene indicated that she would contact the club and invite them to present to the Village Board.

INTRODUCTORY LOCAL LAW #7-2011

VILLAGE OF SPENCERPORT, MONROE COUNTY A LOCAL LAW TO PROVIDE FOR IN-LAW APARTMENTS IN THE R-1 AND PRD DISTRICTS

WHEREAS, the Village Board has before it a proposed Local Law to amend the zoning code to allow for In-Law Apartments in R-1 and PRD Districts upon the issuance of a temporary Special Permit by the Zoning Board of Appeals; and

WHEREAS, in order to make said change, the Village Board of the Village of Spencerport is required to hold and conduct a public hearing thereon;

NOW, THEREFORE, BE IT RESOLVED:

SECTION 1. The new ambulance is in route and will be paid for with a combination of cash on hand and a loan from Spencerport Federal Credit Union.
