Mr. Jack Crooks submitted his monthly report and explained that works continues on the Visca Big Ridge Road project and are nearing completion and C of Os will be issued upon final inspection. Mr. Crooks continued that he has reviewed the drawings for the McDonalds renovation and that the project is on schedule to start in approximately two weeks. Visca's application for the private drive on Big Ridge Road will be presented at the November Planning Board Meeting; fuel pumps are being replaced at the gas station on Spencerport Road and Union Street; a significant fire on Coventry Drive and clean up continues; met with Attorney Stowe regarding Planning Board items. An application has been received for antenna changes on the cell tower located at the DPW Shop and will be going in front of the Planning Board to make those changes. Political sign located at the corner of Union Street and Lyell Avenue is potentially obstructing visibility and Mr. Crooks will be looking into this.

INTRODUCTORY LOCAL LAW #3-2012 VILLAGE OF SPENCERPORT, MONROE COUNTY

A LOCAL LAW TO ESTABLISH A PUBLICITY FUND FOR THE VILLAGE OF SPENCERPORT

WHEREAS, the Village Board has before it a proposed Local Law to create a publicity fund; and

WHEREAS, in order to enact this Local Law, the Village Board of the Village of Spencerport is required to hold and conduct a public hearing thereon;

Mayor Lobene indicated that she will be meeting with both of the volunteer dock masters to discuss the dock usage code and if revisions are needed; annual Boy Scout Christmas Tree Sale will be taking place between November 23^{rd} – December 25^{th} , 2012; Mayor Lobene indicated that from the Bicycling brings Business that many communities are renting canoes and kayaks along the canal and it is an opportunity that the Village might want to look into.

Trustee Rauber indicated that Trolley Depot operations have ceased for the season and there will be Halloween and Holiday events at the Depot.

Trustee Penders informed the Village Board that the East Avenue Heritage Trail project will need to take a loan from the Sewer Fund to cover costs until grant funds are received for the project.

Trustee Gunther indicated that the neighbors of the Big Ridge Road area are putting pressure on him regarding the Planning Board's decision and inquired if the next Planning Board meeting is when a decision will be made.

Attorney Olson responded that Attorney Eric Stowe is aware of all of the issues surrounding the application and is working with the Planning Board members.

Superintendent McIntee indicated that he has successfully applied for a NYSERTA Grant for LED light bulbs to give away to customers; working with Frontier regarding the installation of fiber cable.

Clerk Sullivan passed out the preliminary budget calendar for the 2013/2014 fiscal year and updated the Board on the camera project and will be meeting with Monroe County regarding connectivity.

Superintendent West reported that Heritage Trail Phase I have been completed and that the Canal Authority will be cleaning the south side of the canal from the DPW to the Union Street Bridge. Superintendent West indicated that the Superintendent's Association will be reimbursing the Village for the hotel portion of the upcoming NYCOM conference.

Trustee Penders reported on the Bicycles bring Business conference indicating that the Village does a good job at having benches and accommodations for the bikers and that the one thing that maybe lacking is adequate signage to show area attractions.

Mr. Kris Schultz gave the Village Board photos of the dilapidated fencing separating the Village Municipal Lot from the Post Office parking lot. Mr. Schultz continued that the situation not only looks bad but is a hazard.

Discussion ensued regarding the area, remediation and potential improvements.

Mrs. Elaine Spaziano addressed the Board regarding the history of Christmas on the Canal and need for the Village's financial support for the event.

Attorney Olson explained that the Village supporting a Christmas event violates the first amendment of the US Constitution and cannot be done.

Mayor Lobene introduced Mrs. Sandy Mitchell, as the new Village Historian, Mayor Lobene continued indicating that it is a volunteer position and that she will be working on the potential of instituting a historical district and identifying other historical items relevant to the Village.
