Trustee Nellis-Ewell indicated that was correct and that the Code Enforcement Officer should follow up with the business if the signs are not code compliant.

Mr. Dan Goodison, Union Street questioned that status of the two hour parking in the municipal lot on West Avenue and Church Street and emphasized the importance of the two hour parking.

Trustee Nellis-Ewell responded that the local law process must be followed to legally post the lot for two hour parking.

Further discussion ensued regarding the need for two hour parking in that lot.

Trustee Nellis-Ewell commented that the following businesses received certificates of appropriateness for their signage application: Big Ridge Holdings, Page Countryside, and Shultz Associates. In addition Mr. Schultz indicated that two hour parking would help the lack of parking in his parking lot.

Mayor Lobene indicated that the issue with the fence at Mr. Matthew Brooks' (McColley's Pub) property has been resolved.

Trustee Granger responded that the issue is not resolved and that the property owner had no intention to take down the fence and now he is asking for an extension.

Trustee Granger made a proposal that the Village Board rescind Mr. Brooks' permission to have the fence.

Mr. Goodison questioned what the issue is.

Trustee Nellis-Ewell indicated that Assistant Building Inspector Jack Crooks and Code Enforcement Officer Kevin Kelly issued a memo the Village Board regarding the fence located on the sidewalk at McColley's Pub owned by Matthew Brooks recommending that the Village board grant a stay of the agreement for the fence until December 15, 2013. Mr. Brooks indicated that he will provide the Village Board with a proposal outlining a strategy for the fence, protection of pedestrian traffic and bringing the out swinging entry doors into code compliance.

Trustee Granger commented that Mr. Brooks is going to submit a plan, not remove the fence.

Trustee Penders indicated that alcohol cannot be sold or consumed in a public sidewalk café and that the façade of the building was changed to allow for this café.

Mr. Goodison indicated that he does not understand the snow remove issue with the fence when there is less space to remove snow from sidewalks in other areas of Union Street.

Superintendent West explained the snow removal process and that the area in question has a tendency to have an abundance of snow accumulation making it difficult to remove with the proximity of the fence.

Mr. Goodison indicated that Mr. Brooks is willing to remove snow in front of his building.

Superintendent West was not aware of Mr. Brooks' intentions.

Mr. Goodison added that he feels that this is an obstruction of the promotion of business. Mr. Goodison summarized that Mr. Brooks is adding to the business of the Village and the Village Board continually says no to Mr. Brooks.

Trustee Granger indicated that there is more information to the situation.

Discussion ensued regarding the fence and the promotion of business.

Green Initiatives – Trustee Nellis-Ewell, Chair

Subject: Report on Green Refuse Truck

According to the Village of Spencerport Major Equipment Project Summary, 2013-2014 Budget, the refuse truck is due for replacement. \$216,000 is estimated as the replacement cost.

Goal: Save fuel and cut emissions by purchasing an economical, reliable refuse truck

- Focus continues on "green" vehicles commercial, municipal and personal models.
- To gain basic knowledge, hours were spent to research, read and review options.
- From sustainability and equipment activities, we gained more knowledge on types of trucks: Compressed Natural Gas (CNG), 2) Electric/Hybrid and 3) Hydraulic Hydrid (chassis retrofitted). In June, Superintendent West and I toured the new CNG installation (\$!M) at local Suburban Disposal Company.
- 1) and 2) need expensive infrastructure: fueling, charging stations (limited number, most not open to the public) and training. BAE Systems, Bosch, Eaton, Parker-Hannefin, and Peterbilt were contacted: companies, reps, references.
- Some municipalities have implemented green vehicles, mainly large fleets in major cities. Traditional vehicles can be converted to CNG, but few systems have been approved for vehicles over 14,000 lbs. (EPA working on).
- Our analysis determined frequent "stop & go" of Village refuse routes made Hydraulic Hybrid the best choice. Data indicates fuel savings of 30%, but we estimated conservatively at 15-20%. Sources:
 - U.S. Department of Energy, Energy Efficiency & Renewable Energy, Alternative Fuels Data Center <u>www.afdc/gov</u>
 - Clean Cities Guide to Alternative Fuel and Advance Medium- and Heavy-Duty Vehicles
- Funding might be available from various grants. New York Governor Cuomo's "Cleaner, Greener Communities" applies to smaller vehicles. **Overall a "green" truck must offer reasonable payback and ROI.** Examples: Village of Fairport considered a Hydraulic Hybrid; chassis cost alone was \$275,000. Truck prices range from \$220,000 (same specs?) to \$388,000 (New Haven, Connecticut).

Conclusion - Hydraulic Hybrid Technology * Purchase not recommended at this time

- Still new (getting better)
- Range of specs (extensive)
- Expensive to purchase (variable)
- Locked into manufacturer service (not local)
- Unknown maintenance record
- Unproven performance in smaller New York municipalities, particularly New York winters

In summary, it is important to advise taxpayers the Village of Spencerport did due diligence to this green project. Thank you to Superintendent West for being open-minded and helpful, by making numerous phone calls and sending follow up e-mails to gather information that enabled careful assessment.
