Mr. Patrick Smith commented and submitted to the Village Board his 2013 Building Department report for the Village along with 2012's report for comparison and indicated that activity has increased since last year. Mr. Smith suggested that a code revision regarding the construction of new buildings/homes be made to require a certified survey confirming the basement floor elevations to ensure that the elevations are correct with the approved plans for the home. Mr. Smith indicated that the Town would be making this code revision and that there have been incidents in the town where the elevations of the basement floors have been lower than approved plans and could lead to basement water problems.

Trustee Hopson requested that Rich McQuilkin take a look at the boat and trailer in the lots on Brockport Road and 28 N. Union Street.

Mr. McQuilkin responded that he will look into these items.

Attorney - (4:30 p.m.) - R. Olson

Attorney Olson commented that he circulated the draft incentive zoning agreement to the Village Board for comment. Attorney Olson added that the SEQR resolution has been prepared for action tonight however SEQR does not approve the plan or incentive zoning it starts the clock to establishing the lead agency (Village of Spencerport) should the project be approved.

Mayor Lobene asked the Village Board if they had any questions regarding the draft agreement. There being no specific questions discussion ensued regarding the proposed changes to the code, amenities and their value to the Village.

Trustee Penders commented that none of the six items that were discussed at the October 7, 2013 meeting regarding amenities have been addressed in the agreement. Trustee Penders continued that the proposed amenities benefit the project more than they benefit the Village and that all of the items listed need to be done as a result of the project not in addition to the project.

Trustee Nellis-Ewell commented that the development is taking away green space and the project may not entirely be in the spirit of the Village's comprehensive plan. Trustee Nellis-Ewell commented that amenities can be cash and that a new village hall should be discussed and additional time is needed to review the agreement.

Trustee Penders added that he would be in favor of cash amenity.

Mr. Kris Schultz commented that the outlined amenities directly coordinate with the various Village approved documents including the comprehensive plan regarding the development of the Village specifically the extension of East Avenue and the Canal area.

Attorney Dougherty commented that the developer at this time could construct an industrial appropriate project and offer no amenities associated with the Village's comprehensive plan however this project benefits both the developer and the Village as it relates to the comprehensive plan.

Mr. Schultz commented that he had discussions with Superintendent West regarding the culverts and parking, discussion has taken place with the ambulance as well in addition Mr. Schultz has spoken with the developer regarding the other six items on the list.
