Mayor Granger called the meeting to order at 4:30 p.m.

BI/CE/FM - (4:30-5:00 p.m.) - P. Smith/R. McQuilkin

Mr. McQuilkin commented that he performed three (3) building inspections on Gaslight and Villager Apartment Complexes and Ontrack Property and they are all set; Re-inspections were conducted at Pontillos Pizza (500 S. Union Street), Rancho Vejo Restaurant (500 S. Union Street) and 500 S. Union Plaza common areas due to last month's Order of Remedy served on the property owners of 500 S. Union Street and everything is all set now; 21 Union Hill Drive elevator was inspected and the emergency communications in the elevator was missing and has been corrected at this time and Walker Brothers Funeral Home was re-inspected at this time and compliant.

Mr. McQuilkin addressed a handicap parking issue and water leak issue at the Chef King Restaurant in the Village Plaza and indicated to the Village Board that Mr. Pelusio is no longer owns the Village Plaza property and the new owners are Spencerport Investors LLC and has spoken specifically to Cheryl at Spencerport Investors LLC and she indicated that the Cabot Group is now the property management company. Mr. McQuilkin continued that Cheryl indicated that they want to take care of all of the issues in the plaza.

In addition Mr. McQuilkin has made contact with 2 bulk/residential refuse issues. Mr. McQuilkin continued that he and Patrick Smith, Building Inspector met with Larry Fennity regarding the White Church kitchen remodel project. The group was attempting to come up with an economical solution to the installation of an Ansel Fire Suppression hood in the kitchen. Mr. McQuilkin indicated that he spoke to Eric Bradshaw from NYS Code Division to determine if there were any other types of hoods that could be installed to be compliant. Mr. Bradshaw replied that the Village could give permission not to require the Ansel System however the C of O has to be specifically written to confirm that no grease producing cooking is being done in the kitchen and if it is found that grease producing cooking is being done either the kitchen is shut down or an Ansel System needs to be installed. At this time a small self-contained extinguishing system to be installed with residential type stoves is being proposed at this time. This method would be cost effective for the church and still have the fire protection that is necessary. At this time the church is going out to bid for these items.
