VILLAGE BOARD MEETING April 1, 2015 Minutes

Trustee Penders called the meeting to order at 7:00 p.m. followed by the pledge of allegiance.

Approval of Minutes

A motion was made by Trustee Hopson, seconded by Trustee Nellis-Ewell and carried that the meeting minutes from the March 4, 2015 Village Board Meeting be approved as read.

A motion was made by Trustee Kuntz, seconded by Trustee Nellis-Ewell and carried that the meeting minutes from the March 11, 2015 Village Workshop Meeting be approved as read.

Public Hearing

Trustee Penders opened the Public Hearing regarding the Tentative 2015-2016 Budget at 7:03 p.m.

Treasurer Kimbler explained the 2015-2016 Tentative Budget highlighting that the proposed tax levy for the General Fund is \$664,165 resulting in a tax rate of \$3.56 per thousand of assessed value and a recycling charge of \$51.27; the proposed tax levy for the Sewer Fund for O&M charge is \$250,679 resulting in a tax rate of \$2.93 per thousand gallons of water used; Capital Charges per sewer unit would be \$140.61. The increases would result in a resident with a home assessed at \$100,000 would pay approximately \$10 more in taxes than last year. The Village of Spencerport continues to budget below the 2% tax cap.

Treasurer Kimbler explained that the Village Board adopted strategy to manage the Village's fund balances with the following comments: Sewer fund continues to work off Unreserved Fund Balance to reduce Capital charges on the tax bill per the Village Board's established schedule; General fund is challenged with stretching what is left of our Fund Balances to continue to support services and future needs without requiring huge tax increases in out years; Budgeting focused effort to more closely budget expense, understanding that certain amount of contingency is needed and is appropriate within state guidelines; Reserves are used to balance out year to year cost fluctuation and to pay for one time investments.

Treasurer Kimbler highlighted areas of cost reduction including the reduction of seasonal/summer help; extending the life of vehicles and equipment, continued need for infrastructure rebuild but on a slower pace; lower utility costs with the installation of solar, LED, natural gas and the continued negotiation of lower pricing for contracted services.

Treasurer Kimbler explained the major projects for the General, Sewer and Electric Funds to include the annual roads program, sewer I&I, vehicle replacement, various repairs to infrastructure, rebuild of overhead primary circuits, street lighting LED conversions, street light installation in Domus tract, rear lot pole replacement, substation improvement and DPW/SME shop structure rebuild.

Treasurer Kimbler explained the allocation of General and Sewer fund expenses and the source of funds for General expenses.

General questions ensued regarding the various line items within the budget.

Mr. Terry West commented that Treasurer Kimbler did great job on the budget presentation.

Mr. Craig Byham complimented Treasurer Kimbler and the Village Board for doing a nice job putting together the presentation and budget.

Trustee Nellis-Ewell asked Superintendent West to explain the CHIPS process that he goes through and the definite number that the Village is going to receive.

Superintendent West responded that he does not have a definite number that the Village is going to receive however we do receive approximately \$54,000 per year. These funds are generated from the gas tax and approximately \$.62 of gallon of gas purchase is supposed to go back the municipalities throughout the state. The funds are controlled at the state level and only 3% of the total funds are distributed to local municipalities the balance of the funds are used for state projects such as the rebuild of the Tappan Zee Bridge project. Annually local municipal superintendents attend Advocacy Day in Albany to speak with state representatives to stress the importance of continuing the local CHIPS programs.

Mrs. Joan Quigley questioned why the DPW/SME Shops are moving to natural gas.

Superintendent McIntee responded that natural gas heat in those buildings is more efficient than electric heaters in addition a natural gas generator will be installed at the shop for emergency operations.

Trustee Penders commented that NYCOM released a statement indicating that grants are available for various infrastructure projects throughout the next year. Trustee Penders continued by thanking all of the staff for their work putting the budget together.
