Under the matter of unfinished business, the meeting was for the purpose of adopting the final scope for the Mavis Tire Store proposed to be located at 26 Slayton Avenue, Spencerport, NY 14559. The scoping process resumed with the Final Scoping Document for the Mavis Discount Tire Store presented. Planning Board members provided input regarding the areas of impact: Noise, Transportation, Comprehensive Plan and New York State Barge Canal. The Final Scoping Document was to be sent to the applicant.

Banner signage on Village of Spencerport lift bridge over Erie Canal

Mr. Haines showed the old banners, explaining the two new ones proposed would be made by Natale Signs from the same 18-gauge vinyl, white background with green lettering "Welcome to Spencerport", accented in black. The Chamber Website www.spencerportchamber.org would be added to enable boaters and others to search for member businesses and services. Each banner would be 4 feet x 25 feet. Mr. Haines would affix the unlit banners with plastic zip tags on the east and west sides of the lift bridge during the annual "Canal Season" – May 1 through October 31. Mr. Haines contacted the New York State Canal Corporation, who referred him to the New York State Department of Transportation (DOT). Since the lift bridge is on State Route 259. The DOT approved his request for a permit. The Board members agreed it should not be necessary for the applicant to appear again.

Zoning Board of Appeals (ZBA) meeting May 21, 2015

Public Hearing, Village of Spencerport Village Office, 27 West Avenue, Spencerport, NY, 14559, 7 PM

Application of Sarah Infantino, 80 Mill Street, Spencerport, NY, 14559 for a special permit for a privacy fence, 50 feet in length of 6-foot high and 180 feet in length of 4-foot high to replace existing chain link fence on property located at same, whereas, a Special Permit from the Zoning Board of appeals shall be required for a privacy fence, pursuant to Chapter 340-32.A(4)(a) and two (area) variances; one for the total length of 230 feet, and one for the location of fence being near the lot lines, whereas, any privacy fence must be located not nearer to a side line or rear line than the required side line or rear line setback, and shall not exceed a total length of 65 feet on any one lot, pursuant to Chapter 340-32.A(4)(b) in a Residential District.

Ms. Infantino explained the foremost reason for the proposed fence is to contain her friendly dog, a "digger" who escapes (the chain link fence), and wanders the neighborhood. Discussion ensued with Zoning Board members asking the availability/source of the material in 4-foot heights and advising about installation: who, how, distance from lot lines, maintenance and mowing.

No one from the public appeared to comment. A letter was received from a neighbor stating no objection. Chair John Dole then closed the Public Hearing.
