VILLAGE BOARD MEETING September 2, 2015 Minutes

Mayor Penders called the meeting to order at 7:00 p.m. followed by the pledge of allegiance.

Approval of Minutes

A motion was made by Mayor Penders, seconded by Trustee Hopson and carried that the minutes from the August 5, 2015 Village Board Meeting be approved as read.

A motion was made by Mayor Penders, seconded by Trustee Wohlers and carried that the minutes from the August 19, 2015 Village Workshop Meeting be approved as read.

Public Hearing – Introductory Local Law 4-2015 "A Local Law to impose a Gross Utility Tax"

Mayor Penders opened the public hearing at 7:01 p.m. by reading the local law.

Mr. Frank Nichols, Coventry Drive – commented that the Gross Utility Tax was brought to a public hearing a few years ago and that he was the only one to speak about it indicating at that time it would affect the churches and fire department. Mr. Nichols continued that he was at the Village Hall and they indicated that the law was the same as the previous law. Mr. Nichols questioned what utilities would be included in this tax.

Mayor Penders responded Vontage, Time Warner Digital, Frontier, RG&E gas and electric.

Mr. Nichols responded not Village Electric and will anyone be exempt from this tax.

Mayor Penders responded that Village Electric is exempt and no one will be exempt from the tax.

Mr. Nichols indicated that last time someone said that it almost adds 2% to the utility bill and that all businesses and not for profits will be effected by this tax since they use gas for heat making it inequitable and that anyone in the Village that heats with electric is exempt from the tax. Mr. Nichols continued that he does not have a land line and does not understand how Vontage would apply the tax. Mr. Nichols continued by explaining how churches are taxed and pay utilities and the inequities of the tax.

Mr. Nichols questioned the anticipated revenue from this tax.

Mayor Penders responded that he does not know at this time however it was determined that approximately \$25,000 could be realized from this tax.

Discussion ensued regarding the revenue realized, the inequities and the 2% tax cap.

Mr. Curt Kenyon, S. Union Street indicated that he understands the need for the Village to raise revenues and that through his research he found that the disadvantages of this is that fixed income residents may not have the extra income to afford the tax in addition to their current bills; also a business that may have several telephone lines however sells an item that has a lower profit margin will be adversely affected by the tax, thus the tax is discriminatory based on income and usage.

Mr. Kenyon added that he did some research on his own expenses at his business and he figured he would realize an 8% increase in expenses if this tax was enacted along with increased taxes due to reassessment raising the amount to about 24% over the last two years.

Mr. Ron White, Hawthorn Drive commented he feels that the businesses would have an additional cost burden as well as residents if this tax is passes. Mr. White confirmed that water is not included in this tax.

Attorney Stowe responded that water is exempt.

Discussion ensued regarding included and exempt utilities under this tax.

Mayor Penders closed the public hearing at 7:20 p.m.

Mayor Penders commented that the Monroe County Association of Mayors are looking into reducing the minimum speed limit in villages from 30 MPH to 25 MPH. This initiative is being brought forward to legislatures in Albany by Mayor Corby of Pittsford. This thought behind this to help clam traffic for safety purposes.

Trustee Nellis-Ewell questioned if Mayor Corby had any data regarding the reduction in speed as it pertains to safety and lowering fuel consumption.

Clerk Sullivan commented that there were 42,000 vehicle passes at the speed sign located on West Avenue from July 23rd through September 2nd. 8.8% of those vehicles were speeding; most violations were during the work day and the maximum speed was 50 MPH.

Work continues on the installation of a new fire/security system at the shop.

The Village's information pertaining to the Monroe County Hazard Mitigation Plan has been submitted to be included in the plan.

Mayor Penders commented that the plan is quite involved and will be a plan for the entire county and will be filed under the WebEoc website.

Superintendent of Public Works – Thomas M. West

Superintendent West indicated that he is using a top soil machine from Monroe County to convert the Village's leaf/compost pile into top soil pile. This process will save the Village the expense of purchasing top soil for various projects.

Trustee Hopson commented that the repaying of Brockport Road is the smoothest road he has been on in a long time.

Mayor Penders thanked Trustee Hopson for his comments indicating that lately there have been some very rude people in our office berating our staff as to how the Brockport Road project was handled. Mayor Penders continued that Brockport Road is unique because it has concrete underneath the black top compared to a traditional road.

According to recent studies, the Canal system helps support \$6.2 billion in annual economic activity, plus \$380 million in tourism-based spending. Parks & Trails NY established that the Erie Canalway Trail – which parallels the Erie Canal from the Hudson River to Lake Erie -- has an economic impact of about \$253 million annually and supports 3,440 jobs in the trail corridor.
