Hi Donna,

Good day! Hope this email finds you well. As a result of our investigation and consultation with other payroll specialists and technical support department, it is our regret to inform you that there is no way to program the system to automatically only take out \$0.90 cents for their NY SDI tax.

The only solution is to create a batch that would contain a column for ADJUST STATUTORY DEDUCTION FOR SUI/SDI and input in manually in your batch or paydata grid. Please see instructions:

In the Paydata Batch

- > Click Insert
- > Column
- > paydata Field dropdown box, choose: Replace Statutory deduction
- > choose SUI/SDI for the code
- > done

Input .90 for each employee

You may archive a batch with this column already set up so you do not have to add the Adjust Statutory deduction Column for SDI/SUI everytime you run your payroll.
