Trustee Hopson updated the Village Board on the refuse carts program. Trustee Hopson indicated that the Village has 1139 refuse stops and 950 carts have been put into service. At this time there are 259 stops without refuse carts. 43 stops on the north side of the canal route; 110 stops on the Lyell/Coleman Avenue route; 54 stops on the Harwood/Laurelcrest route and 52 in the Village Walk/Brockport route. Trustee Hopson continued that 77% of stops have refuse carts and that reminder letters are being mailed by area to stops that do not have refuse carts with most recently being the Village Walk/Brockport route and there have been no additional purchase of refuse carts. Inventory will be restocked by mid-February.

Trustee Nellis-Ewell questioned if these totals included rentals or is it just single family homes.
