Attorney Stowe commented that the bank holding the letter of credit for Canalgate has indicated that it will be expiring on May 12, 2016 and if the outlined work in the letter of credit is incomplete at that time the Village could call in the letter of credit and hold the money is escrow for the developer or request the developer to extend the letter of credit. Attorney Stowe advised that he make contact with the developer, Steve Liccardello, to determine what he would prefer and move forward at the next meeting.

Trustee Nellis-Ewell asked Trustee Hopson the total of rolling refuse carts that still need to be put into service.

Trustee Hopson indicated that there are 217 stops that still require rolling refuse carts.

Trustee Nelllis-Ewell commented that moving forward that orange tags will be affixed starting April 1st and then notification from the Code Enforcement Officer and then a potential \$250 fine. Accommodations will be made for residents' with restrictions based on ADA requirements.

Clerk Sullivan indicated to the Village Board that due to the restrictions and cost of the Village continuing to be a registered electronics drop off site she would like to look into discontinuing our drop off site registration however continue to pick up our residents e-waste and disposing of it properly.
