<u>December 7</u> – Today is the 75th anniversary of the attack by the Japanese on Pearl Harbor, Honolulu, Hawaii. It is time to reflect on the sacrifices made by the United States on that memorable day.

The attack claimed the lives of 2,403 Americans, most on ships bombed at the Pearl Harbor naval base. 1.177 crewmen were killed on the USS Arizona.

Today only a handful of Pearl Harbor survivors still live in Hawaii; indeed, most survivors are in their 90's. A volunteer-staffed museum exists on Ford Island.

To quote President Franklin D. Roosevelt: "Yesterday, December 7, 1941 – a date which will live in infamy –

the United States of America was suddenly and deliberately attacked by naval and air forces of the Empire of Japan." President Roosevelt further stated Japanese forces attacked Malaya, Hong Kong, Guam, the Phillipine Islands and Midway and Wake Islands.

The President concluded: "As Commander-in-Chief of the Army and Navy, I have directed that all measures be taken for our defense. But always will our whole Nation remember the character of the onslaught against us..."
