Mr. Darin Ramsay - Clean Energy Community Coordinator of the Genesee/Finger Lakes Regional Planning Council explained the ten high impact actions that would allow for the Village to become a Clean Energy Community. Mr. Ramsay further explained that the Village would have to demonstrate the completion of four of the ten high impact actions. To earn the Clean Energy community designation, at least two of the high-impact actions must be complete after August 1, 2016. The high-impact actions include: 1. Benchmarking energy usage in municipal buildings; 2. Clean Energy Upgrades – achieve a 10% reduction in greenhouse gas emission from municipal buildings through energy efficiency upgrades and renewable energy; 3. LED Street Lights; 4. Clean Fleets; 5. Solarize; 6. Unified Solar Permit; 7. Energy Code Enforcement Training; 8. Climate Smart Communities Certification; 9. Community Choice Aggregation; 10. Energize NY finance.

Deputy Mayor Nellis-Ewell indicated that she and SME Superintendent McIntee would work on developing a strategy to become a Clean Energy Community.

Code Enforcement Office Rich McQuilkin made the following report: 5 fire inspections conducted; 5 re-inpsections; 6 bulk issues; 1 additional garbage issue; 2 TVs with no stickers; 1 tire with no sticker; temporary signs and unregistered vehicles for sale at Spencerport Bowl; Banner at Mangia Mangia; temporary sign at Rivoli & Rivoli and attended the Monroe County Fire Marshal's meeting on 2/15/2017.

WHEREAS notice of public hearing was duly given and said hearing duly held on the 1st day of February, 2017 to consider the enactment of the local law described below:

Whereas, this is an unlisted action under the State Environmental Quality Review Act Regulation §617.5(c)(20)&(27) and does not have any significant environmental impacts and is not subject to further review under said regulations;

WHEREAS all interested persons were given an opportunity to be heard with respect to the enactment of said local law;

NOW, THEREFORE, BE IT RESOLVED, that Local Law No. 1 -2017 be enacted as follows:

LOCAL LAW NO. 1-2017

A LOCAL LAW TO PROVIDE FOR THE CODIFICATION OF THE LOCAL LAWS, ORDINANCES AND CERTAIN RESOLUTIONS OF THE VILLAGE OF SPENCERPORT INTO A MUNICIPAL CODE TO BE DESIGNATED THE "CODE OF THE VILLAGE OF SPENCERPORT"

This local law:

- (1) States the legislative intent of the Board of Trustees in adopting the Code.
- (2) Provides for the designation of the local laws, ordinances and certain resolutions of the Village of Spencerport as the "Code of the Village of Spencerport."
- (3) Repeals local laws and ordinances of a general and permanent nature not included in the Code, except as provided.
- (4) Saves from repeal certain local laws and ordinances and designates certain matters not affected by repeal.
- (5) Retains the meaning and intent of previously adopted legislation.
- (6) Provides for the filing of a copy of the Code in the Village Clerk's office.
- (7) Provides for certain changes in or additions to the Code.
- (8) Prescribes the manner in which amendments and new legislation are to be incorporated into the Code.
- (9) Requires that Code books be kept up-to-date.
- (10) Provides for the sale of Code books by the village and the supplementation thereof.
- (11) Prohibits tampering with Code books, with offenses punishable by a fine of not more than \$250 or by imprisonment for not more than 15 days, or both.

- (12)Establishes severability provisions with respect to the Code generally.
- (13)Provides that the local law will be included in the Code as Chapter 1, Article I.
