Resolution 140 4/2017

Whereas, the Village of Spencerport participates in the Upstate New York Municipal Workers Compensation Program (UNYMWCP); and

Whereas, the Board of Directors of the UNYMWCP has recommended the establishment of workers compensation insurance reserves by member municipalities in the event that the deposits paid into the UNYMWCP do not cover the claim liabilities/judgements; and

Whereas, the Village Board of Trustees of the Village of Spencerport so desires to establish such a Workers Compensation Insurance Reserve.

Now Therefore Be it Resolved

Section 1: That pursuant to Section 6-n of the General Municipal Law, the Village Board of Trustees of the Village of Spencerport does hereby establish a Workers Compensation Insurance Reserve Fund for the purpose of covering claim liabilities/judgments in excess of the deposits paid into the UNYMWCP.

Section 2: That surplus monies from the UNYMWCP are appropriated for the Workers Compensation Insurance Reserve Fund.

Section 3: That the Treasurer is hereby directed to deposit monies of this reserve fund in a separate bank account to be known as the Workers Compensation Insurance Reserve Fund.

Section 4: That the Treasurer is authorized to invest, from time to time, the monies of this fund pursuant to Section 11 of the General Municipal Law.

Section 5: That such additional sums as may hereafter be appropriated shall become part of the fund.

Section 6: That no expenditure shall be made from this fund, except upon authorization of this board pursuant to Section 6-C of the General Municipal Law, and subject to permissive referendum is required by law.

Section 7: That this resolution shall take effect immediately.
