JUNE Architectural Review/Planning (ARB/PB) & Zoning Board of Appeals (ZBA)

Architectural Review/Planning Boards (ARB/PB) Meeting June 6, 2017

ARB business only Signage applications

Application of Brindle Haus Brewery, 377 South Union Street, Spencerport, NY 14559

John Boothe stated monument signage at the road is to be simple, similar to the wall sign, fitting with other (monument) signs. Chairman Byham requested a copy of the monument sign be sent for review. * John Boothe stated black LED gooseneck lighting will be used. Chairman Byham stated because they are the first business in that building, black is fine. Subsequent businesses would need to follow that color scheme. Chairman Byham thanked the applicant: for an application that was complete and well-done, which made the process easier for everyone. ARB Member Venezky asked how often/long will the lights be on. John Boothe responded lights will be manually controlled by an inside timer. Depending on the time of year, lights will likely be on an hour before dark and shut off sometime in the middle of the night. If appropriate permits are issued by all agencies involved, Labor Day opening is anticipated.

Certificate of Appropriateness issued

Final approval granted with the following conditions:

- Wall sign shall be 4.5 ft. diameter circle on 1/8 inch Di-bond aluminum material with laminated paint.
- Colors and design shall be as depicted on application.
- Signage shall be lit by 2 equally spaced gooseneck lamps as submitted with application.
- Signage and lighting shall be installed in a safe and secure method.
- Signage to be kept in good condition as determined by the VOS ARB.
- After signage is installed, the applicant shall summit a photograph of such to the Village Clerk for filing.
- * Furthermore, the ARB issued contingent approval for monument signage, after applicant submits drawings and specifications to the Village ARB for their review.

Application of Furry Paws, 380 South Union Street, Spencerport, NY 14559

Alanna Dable, owner of Furry Paws, stated Gary Natalie will make the sign.

Chairman Byham asked if the current sign will be used. Alanna Dable responded a new sign will be put up: 1) because of some rust on the old sign and 2) to make it a little bigger. Chairman Byham stated the ARB requests the edges of the sign be scalloped. Alanna Dable agreed. Chairman Byham advised the A frame sign is allowed, but must be taken in and out daily. * Alanna Dable stated the sign will not be lit at

this time. Chairman Byham advised if it is to be lighted in the future, the applicant would have to come back to the ARB.

Certificate of Appropriateness issued

Final approval granted with the following conditions:

- Size of sign shall be 24" x 96" on Di-bond aluminum material with scalloped corners.
- Sign shall be mounted in a safe and secure manner directly above door and window at the business.
- Colors as depicted on application.
- Signage shall be unlit.
- Signage to be kept in good condition as determined by the VOS ARB.
- After signage is installed, the applicant shall summit a photograph of such to the Village Clerk for filing.* Furthermore, the ARB issued approval for a free-standing A-frame sign with the understanding that such sign must be taken in and out every day. Note: Alanna Dable is buying an existing business; cats are groomed by appointment.

Application of Pin Chasers, 45 Nichols Street, Spencerport, NY 14559

Brian Davies, Pin Chasers manager, stated the sign is from the former business, CJ's; they are looking to replace that sign with their own. Chairman Byham stated in 2010, you appeared for a sign for both the pub and the bowling alley that were never completed. Right now you have two unpainted poles out there. Mike Progno, owner of the building, stated they are not looking to put up any new signage for the bowling alley, only for Pin Chasers. Chairman Byham stated an existing A-frame sign has been out there for many months and it is not the proper size. The Code Enforcement Officer had instructed the applicant to take down that sign. Such letter of violation was read aloud by Chairman Byham. Mike Progno stated the little sign is gone and he put the A-frame by the building. Chairman Byham stated; 1) the sign is too large and 2) vehicles parked in the parking lot are is in violation. Mike Progno stated he addressed those issues already: only one car is in the lot for sale, as allowable by code. Chairman Byham stated the prior sign looks like two field goals sticking out, the sign posts were put in, yet never completed. Mike Progno stated that was not his doing; the owners of CJ's Pub did that sign on their own. ARB Member Venezky asked if the (proposed) sign is the same size as the one up there before. Mike Progno stated he went by the brackets up there; he can make it the same size as the old sign.

Chairman Byham stated the following issues need to be addressed:

- Edges of sign to be scalloped
- Sign needs to fit within the brackets that are there, which is 60 inches
- Drawings with correct dimensions and all required information must be on a new application

At this time the ARB tabled this application pending submission of a new application for such requested signage.

Unfinished Business

JVN Associates, 500 South Union Street, Spencerport, NY 14559 Pergola/Patio area

- Applicant Joe Nucci handed out new drawings of a different pergola. He stated: due to the landlord charging rent now for that area, they could not afford stamped concrete and would be pouring brushed concrete instead.
- Chairman Byham stated: bringing in new plans the night of the meeting was not a practice that the ARB entertained. Furthermore, at the last meeting they were informed: lighting on the building was not what

the ARB approved and needed to be removed from the building, with white gooseneck lighting to be installed.

- Chairman Byham stated until the correct lighting was installed, the ARB would not act on a new application.
- * Applicant was instructed to fix the lighting and submit a complete application no later than June 27, 2017, and that no late applications would be accepted.

At this time the ARB tabled any action on this application.
