Approval of Minutes

Mayor Penders opened the Public Hearing regarding Introductory Local Law 4-2017 A Local Law to add Section to the Village of Spencerport code to be known as "Tobacco, Vaping and E-Cigarettes" at 7:00 p.m.

Mr. Raymond Lally addressed the Village Board indicating that he feels that Vaping should be removed from the proposed local law due to the health risks associated with Vaping are unknown and that from personal experience it can be a useful item to stop smoking.

Mayor Penders responded that a representative from the American Lung Association presented the health risks associated with smoking and the litter that is caused from smoking. The Village modeled their local law after the Town of Ogden's and Vaping is including in theirs.

Deputy Mayor Nellis-Ewell congratulated Mr. Lally on his cessation of smoking and added by reading the April 19, 2017 workshop meeting minutes:

Special Presentation

Lexi Popovici of the American Lung Association and Dr. Ryan Pestena, U of R Medical Center, presented information to the Village Board regarding the health and environmental impacts, and benefits, of adopting a policy to make all Village-owned properties "tobacco free and no vaping, no e-cigs".

Discussion ensued regarding the enforcement of this local law and vaping.

There being no further questions Mayor Penders closed the public hearing at 7:12 p.m.

Privilege of the Floor

Miss Jordyn Czrew, Girl Scout explained to the Village Board her proposed Erie Canal Travel Journal project to obtain her Girl Scout's Silver Award. Miss Czrew continued that the journal would be housed in a structure similar to the "Little Lending Library" currently along the Canal at the Trolley Depot.

Miss Czrew indicated that the project would be fully funded and maintained by her. She requested a spot along the Canal to install the structure and a mentor.

DPW Superintendent Tom West commented that he would install the structure when it is completed and Trustee Nellis-Ewell volunteered to be Miss Czrew's mentor.

Resolution 16 7/2017

Introduced by: Mayor Penders Seconded by: Trustee Hopson

WHEREAS: The Western New York Children's Psychiatric Center opened in West Seneca in 1970. The center takes seriously emotionally disturbed children between the ages of 4 to 18 years old from 19 Western New York counties. The 19 different counties in New York State include: Allegany, Cattaraugus, Cayuga, Chautauqua, Chemung, Erie, Genesee, Herkimer, Livingston, Monroe, Niagara, Ontario, Orange, Orleans, Oswego, Schuyler, Seneca, Steuben, Tioga, Tompkins, Wayne, Wyoming and Yates; and

WHEREAS: Despite the significant volume from these 19 counties the Western New York Children's Psychiatric Center has the lowest 30 day and 90 day reinstatement or re-institutionalization rate of any

facility in New York State. The costs of long term hospitalization and institutionalization are drastically reduced and eliminated when the readmission rates are low; and

WHEREAS: Governor Cuomo in his 2017 Budget proposed that the West Seneca Children's Psychiatric Center be moved to the Buffalo Psychiatric Center, an adult facility and campus. Moving these children into an adult setting would not be therapeutically beneficial and may in fact be detrimental to the psyches of many of these children; and

WHEREAS: The medicinal and therapeutic benefits of treating and counseling children with mental illnesses in both rural and school settings have been documented in many medical journals and academic papers. The Governor's proposal to place these children in a lock down facility with adults runs counter to science, logic and common sense; and

WHEREAS: The New York State Assembly and Senate unanimously passed A6505 / S4630 which prohibit the collocation of certain children's facilities with adult facilities in Erie County; and

WHEREAS: Governor Cuomo needs to sign this bill and save WNY Children's Psychiatric Center in West Seneca.

NOW THEREFORE BE IT RESOLVED: The Village of Spencerport Board of Trustees supports the passage of the above bills in the New York State Legislature and also strongly encourages Governor Cuomo to immediately sign this necessary legislation into law.

Architectural Review/Planning Boards (ARB/PB) Meeting July 11,

2017 ARB business only

Signage application

Application of Howard Hanna Company, 85 South Union Street, Spencerport, NY 14559

Applicant Karen Leonardi stated the Howard Hanna Company bought Nothnagle Realty about two years ago; replacement/revised signage will be similar to existing Nothnagle Realty sign. Chairman Byham requested replacement sign have some curvature and rounded corners.

Karen Leonardi stated the Howard Hanna Company is replacing signs in several other Village locations with signs that fit Board recommendations. Replacement signs must accommodate the Howard Hanna logo. After discussion, Karen Leonardi provided an updated graphic and paperwork. Color scheme remains dark green with gold.

Chairman Byham stated the ARB is looking for this updated design, (scalloped corners, etc.) and same colors.

Certificate of Appropriateness issued

Final approval granted with the following conditions:

- Sign shall be 30 inches x 48 inches, double-sided, HDU material, affixed to pre-existing mast arm.
- Colors and design shall be as depicted on application (gold and green).
- Signage shall be installed in a safe and secure method.
- Signage to be kept in good condition as determined by the VOS ARB.
- After signage is installed, the applicant shall summit a photograph of such to the Village Clerk for filing.

Re-Application of Pin Chasers, 45 Nichols Street, Spencerport, NY 14559

Applicant Brian Davies, Pin Chasers manager, reappeared.

Chairman Byham stated this submitted application is complete with details as required.

Discussion ensued regarding:

Sign posts – unpainted, to be painted with attractive caps.

Existing A-frame sign – Signage on fence, etc.

Chairman Byham reiterated: there is to be 1 free-standing A-frame sign to be brought in & out each day/night.

Conditions noted by Code Enforcement Office verbally and by letter are to be corrected/followed.

ARB/PB Secretary Stassen provided an application for a temporary sign (for events, specials, etc.).

Further discussion occurred re: general code and requirements; for other situations, specifics need to be checked.

Certificate of Appropriateness issued

Final approval granted with the following conditions:

- Sign shall be 45 ½ inches x 60 inches, double-sided, aluminum composite material, with graphics as submitted.- Colors and design shall be as depicted on application (maroon and tan).
- Signage to be unlit, with landscaping at base.
- Signage shall be installed in a safe and secure method.
- Signage to be kept in good condition as determined by the VOS ARB.
- After signage is installed, the applicant shall summit a photograph of such to the Village Clerk for filing.

Unfinished Business

JVN Associates, 500 South Union Street, Spencerport, NY 14559 (Spencerport Hots) Pergola/Patio area

- Applicant Mr. Nucci stated white gooseneck lighting requested by ARB in June is in place. He stated significant investment made in the business/building; his intention is to work with the ARB and Village of Spencerport.
- Corrected lighting acknowledged by the ARB.
- Mr. Nucci handed out new copies/drawings/photos with the original pergola, stating now, no canopy is to be used. He explained: previously the pergola was out of stock, resulting in the canopy option. Concrete pad is brushed concrete, not stamped.
- Chairman Byham stated: concrete was poured right after the June meeting.
- Mr. Nucci stated with landscaping removed, the area was unsafe and unsightly. To be no seating; only two freezers for ice cream and a trash receptacle.

Discussion ensued about post-June meeting communication and instruction.

Chairman Byham stated business/building are in ARB District; therefore, changes/updates such as those related to colors, landscaping must come before the ARB.

It was stated the applicant needs to obtain a Building Permit from Patrick Smith, Town of Ogden office.

Certificate of Appropriateness issued

Final approval granted with the following conditions:

- Installation of pergola as indicated in this application.
- Building Permit to be obtained.
- Pergola to be secured on said patio (pad) in safe manner.
- Following the process to obtain Building Permit, Inspection by Building Inspector.
- Signage to be kept in good condition as determined by the VOS ARB.
- After approved installation, the applicant shall summit a photograph of such to the Village Clerk for filing.

Zoning Board of Appeals (ZBA) Meeting July 20, 2017

Two applications

- 1) Request for variances for garage / height and size
- 2) Request for special permit / conversion single- to two-family house in R-2 District

Building Control – Building Inspector Smith meets with Mayor Penders as scheduled. Code Review – No meetings

Code Enforcement Officer McQuilkin submits regular reports; May/June report submitted for review.

Planning Board Chairman Craig Byham addressed the Village Board indicating that the Planning Board wants to be on the same page as the Village Board pertaining to businesses who seem to think it is better to ask for forgiveness rather than ask for permission before doing things. An example would be the Spencerport Hots. They pulled out all of the landscaping as part of a site plan, left a big hole and filled it with concrete without permission after being told not to do it and Mangia Mangia has banners on his vehicles without permission and their sign that was never granted permission, the bowling alley has painted the exterior of the building, changed the color scheme of the patio including bright lights and now Feltner is painting his building.

Chairman Byham continued that he thinks we need to softly let these folks know that they are in an Architectural Review District and that if we are going to have this district there needs to be consistency and he does not want the Planning Board to get a bad name of being hard-nosed on things, but we try to enforce the rules and regulations as they are given to us and I wanted to make sure that the Planning Board and Village Board are on the same page for these things and what the procedure should be going forward on these types of things.

Mayor Penders responded that the Village Board did instruct the Code Enforcement Officer and Building Inspector to issue a "stop work order" if anything more than the concrete pad was done at Spencerport Hots. Mayor Penders continued that the owners of the Spencerport Hots came into my office on the day the concrete pad was poured asking for the Village Board for help with this issue. Mayor Penders indicated that he supported the Planning Board's decision on the project at that time. Mayor Penders added that somehow we need to get to the businesses to let them know they are in an ARB District.

Chairman Byham agreed and indicated that there is a fast track process for things like painting the building. In addition, Mr. Progno was instructed to take the Karaoke sign down off the fence and he will be given permission to put the sign out front. Mr. Progno took the Karaoke sign off the fence and put it in the window.

Discussion ensued about the bowling alley.

Mayor Penders added that our Code Enforcement Officer has been very diligent in trying to take care of the bowling alley's issues and sometimes people keep pushing the envelope. Mayor Penders suggested that maybe we can work with the Chamber of Commerce to bring awareness to the ARB District.

Chairman Byham added that you don't have to come down hard on people just to let them know that the Village does not want any wild colors.

Discussion ensued regarding the Spencerport Hots plan and various other properties.

Chairman Byham confirmed that the Planning Board and the Village Board are on the same page and that the Planning Board is following the intentions of the Village Board.

Mayor Penders responded that the Planning Board is following the intentions of the Village Board.

Deputy Mayor Nellis-Ewell added that there is information on the Village Website regarding business in the Village of Spencerport and that what we want is consistency and we don't want a reputation of being difficult.
