Zoning Board of Appeals (ZBA) Meeting July 20, 2017

1) Request for variances for garage / height and size

Application of Christopher Somers, 131 Maplewood Avenue, Spencerport NY 14559 for Two (2) area variances to construct a detached 30' x 46' x 17' ("high (1,380 square feet) garage, on property located at same, whereas, the maximum size of a Class II structure shall be 1,000 square feet, and the Maximum height shall be 17', respectively, pursuant to Chapter 340-14 E and 340-14 I in an R1 Residential District. Mr. Somers removed the previous garage because it was too small for multiple vehicles; also, space needed for tool storage and woodworking.

Neighbor who owns the road, stated applicant/s are "welcome neighbors and he is all for it." *Disposition: Both variances granted by Zoning Board of Appeals*

2) Request for special permit / conversion single- to two-family house in R-2 District Application of Jacob Weidert, 50 Chestnut Street #807, Rochester, NY 14604 for a Special Permit for the conversion of a single-family residence to a two-family residence at 271 South Union Street, Spencerport, NY 14559, whereas in R-2 districts only, remodeling or construction of any of the dwellings shall be permitted when a special permit is obtained from the Zoning Board of Appeals, pursuant to Chapter 340-9 G in a Residential R-2 District.

Mr. Weidert stated his intention to be an owner-occupant; other half of the house to be renovated by partition and kitchen addition. No changes to be made to the outside of the structure.

Neighbors' concerns: (area) overrun by rental properties; other multiple-unit homes rundown; rental properties are investment business; (area) overpopulated by rentals; preservation of neighborhood character; inadequate parking.

Mr. Weidert stated nothing had been done to the property since 2008; adequate parking exists for several cars.

Disposition: Required short Environmental Assessment Form (EAF) not included; application tabled. Building Control – Building Inspector Smith meets with Mayor Penders as scheduled.
