- 1) Application of Michelle Streicher, 2 Coventry Drive, Spencerport NY 14559 Request for Special Permit for privacy fence and Area Variance to install approximately 78 linear feet of 6' tall, solid construction on property located at same
- (Special Permit) required for privacy fence and any privacy fence shall not exceed a total length of 65' on any one lot, respectively pursuant to Chapter 340-32 A (4)(a) (for both) in R-1 Residential District. Applicant stated she has two dogs to be contained and that she has spoken with neighbors.
