1) Application of John & Janet Plunknette, 32 Ballard Avenue, Spencerport NY 14559 (represented by Marty Hill, A Best Construction)

Request for an Area Variance to construct a new garage with a peak height of 21 feet, whereas, the maximum height of Class II structures shall be 17 feet, pursuant to Chapter 340-14 I. This is in an R-2 Residential District. Applicant stated the previous structure was a two-story, carriage house with a height of 22 ½ feet. It was damaged significantly during the March windstorm and then demolished. The new structure is to replace it, and is actually further from the lot line. *Disposition: Area Variance granted by Zoning Board of Appeals*
