NOW THEREFORE BE IT RESOLVED:

That the Village Treasurer be and is hereby directed to remove from the Sewer Fund Capital Reserve Fund an amount not to exceed \$25,000 for payments of costs of such Ballard Avenue Pump Station to the DPW.

This resolution is adopted subject to permissive referendum.

Unfinished Business

Mayor Penders shared with the Village Board the NYS DOT's plans to remove two (2) parking spaces on the south west side of Union Street to provide a better angle for motorists to enter and exit the canal bridge. Mayor Penders commented that he is in favor of the NYS DOT's plans and that it would provide motorists a safer and better approach to cross the bridge. Mayor Penders added that there have been mixed feelings from business owners regarding the removal of the parking spaces and wanted to ask the Village Board members their opinion of the removal of the two (2) spaces.

Trustee Kuntz indicated that he was in favor of the removal of the parking spaces to provide safer means of entering the bridge.

Trustee Wohlers indicated that at first, he was not in favor of losing the spaces however after review of the plans and driving over the bridge with his camper he felt that that removing the spots is the best way to provide a better approach to crossing the bridge.
