Note: Recent Mandate to provide cancer insurance for firefighters; estimated @ \$300 per person came in at \$147. This decrease, with an anticipated increase in amounts from auction items, enabled transfers to other important line items.

<u>Tuesday, October 23</u> – 7:00 PM Mayor Penders attended Spencerport Central School District Board of Education Meeting to present a Proclamation to the School Board

<u>Tuesday</u>, <u>October 24</u> – 7:00 PM Attended Town of Ogden Budget Meeting ~ Finance Director Butera reviewed \$7 M + budget components.

Highlights: "Under tax cap, taxes going down", though assessments went up. "Taxes: \$5.59 in Town, \$4.05 in Village." No external debt. Health care increase: 6.5%; employee share from 10% to 12.5%. To support services, equipment includes \$250 K for payloader; \$87 K for police vehicles, plus \$220 K for playground renovation. IT upgrades planned.

Comment: From experience, I recognize the effort required to prepare and present a comprehensive budget. Additionally, it is important to understand related community budgets.
