Applicant's lawyer, Betsy Bruge, Esq., presented first, stated no adverse effect.

Kris Schultz reiterated project details; SRF parking study.

Anthony Alonci, business neighbor, stated "no problem with"/supportive of building, yet does not want to lose restaurant (or their apartments') parking. Tenants call when they cannot find parking spaces.

- Village to possibly post more 24 hr. parking spaces.

- Monroe County Department of Planning & Development sent comments September 11, 2019 Kris Schultz stated project start: "Right away, best while bridge under construction, working it out". Also staging area.

Larry Fennity/Architect: For height variance: land slopes, meaning buildings closest to Erie Canal higher sea level, though not as tall as new building. New building height + sea level height results in about <u>9 ft</u> <u>difference</u>, tallest at decorative pediment/south side, designed to hide a/c unit, etc.
