Patrick Smith, Building Inspector submitted his year to date Village report. Patrick continued that the Town of Ogden has hired an Assistant Building Inspector Sue Duggan and that she is getting familiar with activities in the Town of Ogden and Village of Spencerport. Patrick added that the continued situation with Grandpa Sam's regarding sprinklers will be heard in the Town of Sweden Court to determine whether sprinklers are required.

Rich McQuilkin, Code Enforcement Officer reviewed his monthly report indicating that he conducted 17 fire inspections; 4 re-inspections; 3 Ansul System and Exhaust Hood checks; 2 change of tenant inspections; 1 major in home business inspection; 9 bulk issues; 8 brush issues; 2 freon; 4 TV's; 1 Tire and 9 trailer letters to residents. Rich added that the renovations at J. William Jewelers will require a fire rated ceiling because the ceiling has been opened to complete the renovations.
