LOCAL LAW #6- 2017 A LOCAL LAW ANNEXING CERTAIN LANDS TO THE VILLAGE OF SPENCERPORT

SECTION 1. Authority.

This Local Law is adopted pursuant to a certain Resolution, Findings and Order of the Village Board of the Village of Spencerport approving the Petition for annexation of certain lands within the Town of Ogden to the Village of Spencerport, which Resolution was duly adopted by the Board of Trustees of the Village of Spencerport at a regular meeting thereof, held on the 3" day of September 2014.

SECTION 2. Lands Subject to Annexation.

9. Inform and inspire the public.
