Public Hearing

The application of Jason Wyant, 170 Maplewood Avenue, Spencerport, NY 14559 for an area variance to erect a 6' high privacy fence, along the rear property line on property located at the same; whereas, any privacy fence must be located to the rear of the front line setback and not nearer to a side line or rear line than the required side line or rear line setback, but in no event shall be less than 2 feet from any side line or rear line pursuant to Chapter140-31.A (4), in a R-1 Residential District.

Mr. Wyant stated to the board that he would like to install the fence for privacy because of the driveway for rental property located on Union Street which in within a foot from his lot line. Because it is a rental property there are a lot of cars going in and out.

Chairman Dole: How long will the fence be?

Mr. Wyant: It will probably be 18-20 feet I plan to install a patio right behind the house there. The fence will just be going up along that one section.

Chairman Dole: How would the fence be maintained if it was put right on the property line?

Mr. Wyant: It would be a vinyl fence, low maintenance. I won't put it right on the line but would like it less than 2 feet off the line, it is pretty close in that area to begin with.

Michael Flavin: You would still need to maintain the other side of the fence as far as weeds, etc.

Mr. Swarthout: I am a little confused as to where the fence is going, when I drive into my driveway I have 10 or 15 feet of yard and than a row of hedges are the hedges coming down and the fence going up there?

Mr. Swarthout: Ok, I am all set.

- 2. Fence to be built to professional standards.
