Public Hearing

The application of Jeryd Caruso, 50 Bowery Street, Spencerport for an area variance for a side setback of 1.4" on property located at the same, whereas the minimum side setback is 8% of the lot width measured along the street line or (8% of 66 feet) 5.28".

Such variance pursuant to Chapter 140-12-B (1) in a residential district.

Mr. Caruso stated that he wanted to stay in the Village but their home wasn't large enough and that is why he is putting on the addition. He had already received a building permit but after further review it was found that he would need a setback variance and that is why he is here tonight.

Mr. Caruso also stated that many of the other homes in the neighborhood are also very close to lot lines therefore his house will not look out of place.

Jack Spitz of 63 Bowery Street stated to the Board that he approves of the plans to enlarge Mr. Caruso's house, he stated that 3 – 4 other houses in the neighborhood have been renovated and it has added greatly to the character of his neighborhood.

Building Inspector Jack Crooks stated that in defense of the applicant the property to the north has a garage which is only 20 ft. off the line which is a similar setback as the one being proposed.
